Please refer to your RTI application dated 12.06.2014 received in this unit on transfer on 24.06.2014 for providing information on point No.(3) of your application.

2. In this regard, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Security to an individual is provided on the basis of assessment of threat carried out by the security agencies. Security is also provided by virtue of threat attached to the posts held by some senior government functionaries including Ministers etc. Further details in this regard are exempted under Section 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005.

3. The expenditure on provision of security is incurred by agencies/forces responsible for provision of security. It is difficult to precisely work out the expenditure involved as the same includes salary and allowances to security personnel, communication, transport vehicles etc. which is accounted for under the respective budget head under different security agencies, including state government agencies involved, and such details are not maintained in this office.
