

As per available information w.r.t. Police Acts, 13 State Governments, viz., Assam, Bihar, Chhattisgarh, Haryana, Himachal Pradesh, Kerala, Meghalaya, Mizoram, Punjab, Rajasthan, Sikkim, Tripura and Uttarakhand have formulated their State Police Act and 03 State Governments, viz., Gujarat, Karnataka & Tamil Nadu have amended their existing Police Acts. Thus, 16 State Governments have either enacted State Police Acts or amended their existing Police Acts
