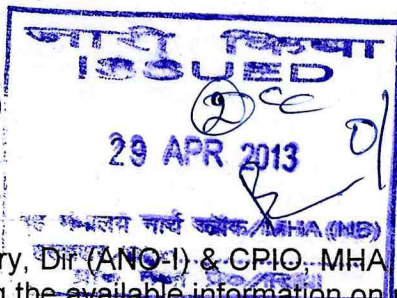
Sub: Information sought under the RTI Act, 2005 vide your application dated 11.3.2013.

2. In regard to information sought vide point nos. (4) to (6) of your aforesaid application, it is informed that the Central Government, inter-alia, reimburses the expenditure incurred by the State Governments under the Security Related Expenditure (SRE) Scheme for payment of ex-gratia to the family of victims of naxal violence at the rate of Rs 1 Lakh per civilian killed and Rs 3 Lakh per security personnel killed. The details of families benefited under this Scheme are not maintained centrally by this Ministry.


