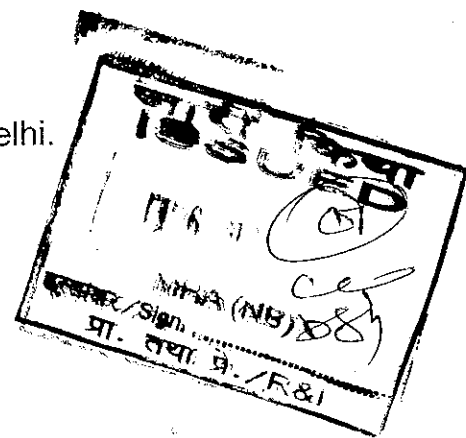

Subject: Application filed by Dr. Nutan Thakur under the Right to Information Act, 2005.


