On the basis of violence profile, presently, 106 Left Wing Extremism (LWE) affected districts in 9 States of the country are covered under the Security Related Expenditure (SRE) Scheme for LWE affected States for the purpose of reimbursement of expenditure incurred by the State Governments on Anti-naxal operations. The list of these districts is enclosed as Annexure-I. The State-wise details of funds released under the SRE Scheme to the LWE affected States during the last 15 years is given at Annexure-II.

2. The information regarding grants provided under the Special Infrastructure Scheme to Left Wing Extremism-affected States is given below:

The Ministry of Home Affairs is implementing the Centrally Sponsored Plan Scheme for Special Infrastructure in LWE affected States from the XI Five year Plan period. The fund is released under the scheme to cater to requirements of policing and security in the LWE affected districts. The works approved under the Scheme are executed by the 9 LWE affected State Governments. After its implementation during XI Plan period, the Scheme was approved on 02.04.2013 for continuation during the XII Plan period with an added objective of funding pertaining to the upgradation and filling critical gaps for Special Forces of LWE affected States. The funding pattern has been changed from 100% funding by the Central Government to 75% (Central Government share):25% (State Government share) pattern. Since its inception, the year-wise funds released under this Scheme are as under:

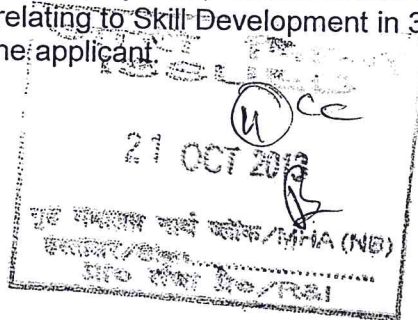
