(2) to (5)	The Ministry of Home Affairs is only administratively concerned with the President's Emoluments and Pension Act, 1951 and the rules framed thereunder, which deals with Salary of the President and post retirement benefits for the former Presidents. As per the aforesaid act and rules the Directorate of Estates, Ministry of Urban Development shall be responsible for arranging accommodation for the former President and the surviving spouse. Your application is, therefore, being transferred to the Ministry of Urban Development for necessary action.

3. As per Section 19 of the Right to Information Act, 2005, an appeal against this letter would lie before Shri S. Suresh Kumar, Joint Secretary (CS) and the First Appellate Authority, Ministry of Home Affairs, NDCC-II Building, Jai Singh Road, New Delhi.

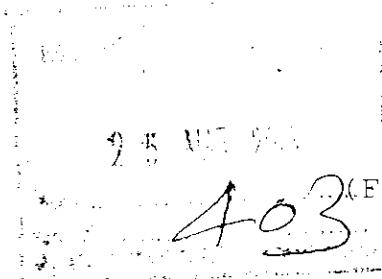
