
Sir,



Background:- During the period, when I was posted as IGP (OPS) of Manipur and Nagalnad a serious incident took place in 61 BN, CRPF, under my Ops command, where in some civilians informers residing in unit HQr with connivance of CRPF officers/personnel, allegedly involved in smuggling of Ganja. Two trucks loaded with ganja was seized at Patna on 11/08/1995. Several CRPF personnel including me were detained by the custom resulting in my deemed suspension w.e.f 22/11/1995. A departmental inquiry for major penalty was conducted and criminal case was also filed in the court.

The DE was finalized and I was absolved of all the charges and the President of India drop<sup>ped</sup> the proceedings. This was conveyed to me (By the order and in the name of President) by Addl. DIGP perse vide order no. D-IX-33/95-CRC dtd. 31/10/2003. I was re-instated in service from date of suspension and ~~whole~~ under suspension period was treated as duty for all purposes. This order was passed by the President (By order in the name of President) and conveyed to me by CRPF memo No. D-IX-33/95-cr dated 04/10/2004. It was mentioned that though the criminal proceeding is pending in the Court <sup>which</sup> will have on direct impact on service benefit. I was paid all the arrears including gratuity. I even committed my pension. I started getting regular pension till march 2008. All our sudden letter was issued by the Assistant Director (Pension) addressed to The Account Officer Central pension accounting office GOI (MOF), Trikot - II, Bhikhaji Gama place, New Delhi-66 dated 9<sup>th</sup> April 2008, copy endorsed to me stating that <sup>supernation</sup> pension authorized in favor of Sri N.K. Tiwary be stopped with immediate <sup>effect</sup> office and both halves of PPO ~~to~~ be returned to his office. Even provisional pension was stopped stating that I have to ~~time~~ return committed value of pension and gratuity. I filed

a writ petition in the High Court. The Court ~~has~~ ordered that Sri Tiwary will not return the committed value of pension and gratuity. Then I was paid provisional pension for 13 month at a time. All this happened because I asked for interest on gratuity. This request was kept pending for almost two years & ultimately even regular pension was stopped.

I will request <sup>final</sup> also note sheet on the file regarding my meeting with director of Finance (MHA) and till disposal of the my application *has also supplied to me,*
