





If a Government Servant (being Adhoc DANICS), under suspension dies after his retirement / superannuation, while drawing provisional pension but before the conclusion of the judicial proceedings against him, kindly provide the following information, when all the judicial proceedings against him are abated by the Competent Court of Law, after his death : -

1. Whether in the case cited here-in above, the period between the date of suspension and the date of superannuation of the said Government Servant shall be treated duty for all purposes ?
 2. If yes, under which Rule ? Kindly provide certified copies of the said rule(s), highlighting the relevant portion.
 3. If no, under which Rule and for what purposes that period shall not be treated as duty ? Kindly provide certified copy of the said rule(s), highlighting the relevant portion.

4. Whether in the case cited herein above, the family of the said Government Servant be paid the full pay and allowances for the period between the date of suspension and the date of superannuation of the said Government Servant ?
 5. If yes, under which Rule ? Kindly provide certified copies of the said rule(s), highlighting the relevant portion.
 6. If no, under which Rule and under which conditions ? Kindly provide certified copies of the said rule(s) and condition(s), highlighting the relevant portion(s).
 7. What is the time limit for deciding the representation filed by the family of the deceased Government Servant before his appointing, disciplinary and cadre controlling authority ? Kindly provide the certified copies of relevant rule / Government Instructions / Orders / O.M.s etc.
