Annex to RTI Application No. PCP/RU-476/RZ/RTI-2013/MHA(DD) dated 8<sup>th</sup> April 2013

On 23-10-2007, the MCD officials *selectively damaged* the Applicant's flat, by resorting to **willful distortion** of material facts *and* submission of **false & mis-leading** reports, *in blatant violation of the extant norms*. The Applicant has been *selectively victimized & targeted for*; (a) filing a legitimate *common interest complaint* for removal of *common space encroachments*, (b) objecting their un-ethical *modus-operandi* of operations; and *finally for*; © resisting & **not** bowing down to the pressures of rampant *corrupt practices*.

Thus, The **illegal modus-operandi** adopted by them to suppress the **legitimate common interest issues**, has grossly violated the **Fundamental Rights** of the Applicant and has caused constant security risks, harassment, mental agony, financial losses and social stigma, since then.

2. Appellant's representations *against* this high-handedness have resulted in **further harassment**, *as the concerned authorities have also preferred to cover up* the deliberate acts of *omission & commission* committed by their officials *rather than* rectifying it. They have completely ignored the facts, submitted by the Applicant for necessary rectifications.

3. Instead of quietly accepting & bowing down to the un-desirable functioning of such officials, the Applicant has preferred to **resist** such forces, for maintaining the sanctity of Institutional incentive to fight corruption. Accordingly, a *thorough* investigation has been carried out by the Applicant *through RTI route* and has submitted a "**Comprehensive Report**" to the Union Home Secretary, on 25-8-2010, requesting to address the grievances as per para 18 of the Report,

4. After going through the *facts & figures*, submitted by the Applicant, the Union Home Secretary *assured* the Applicant to sort out the issue **within two weeks** and marked/sent the Report to AS(UT)/MHA, on 25-8-2010, with the following directions recorded on the Report:-  
**"Please go through and discuss next week. We may need to call MCD officials."**


5. However, the Applicant's *major* grievances have **not** been resolved, so far, *in spite of* submitting additional facts thereon and constantly following up the case with the MHA(DD).

6. **The following information may now be provided, under section 7(1) of RTI Act 2005:-**

- (i) Date-wise progress/action taken, on the said directions of Union Home Secretary.
- (ii) Name & designation of all the officials, who attended/participated in the meeting/discussions held, as per the said directions of Union Home Secretary.
- (iii) A certified copy of the Record of Discussions/Minutes of meetings, held by MHA on the subject and up to date details of the action taken thereon.
- (iv) The decision taken **on para 18 (a) to (e)** of Appellant's Report dated 25-8-2010, read with para 19 & 20 thereof and time-frame prescribed for implementation of the decision.
- (v) The dates, on which the case file has been submitted to the Union Home Secretary.
- (vi) Current status on the said Report, read with the additional facts/representations, submitted by the Applicant to MHA(DD) subsequently.
