Kindly furnish the following:-

1. Furnish name & designation of the entire departmental heads in the Lakshadweep Administration used/using government vehicles (Two wheeler/four wheeler) for their to and fro journey for the last 4 years
2. Furnish the name & designation of the entire departmental heads in the Lakshadweep Administration who have drawn their transport allowance for the last 4 years
3. Furnish no. of posts vacant for the last 6 years in the Lakshadweep Administration (Department wise vacancy)
4. Furnish entire department wise details regarding promotion dues for group C & D employees after completion of his/her qualifying service for his next promotion in the Lakshadweep Administration for the last 6 years and also furnish name & designation of the officer who held the charge of the department during the above period and reason for non consideration for promotion
5. Furnish entire department wise details regarding ACP/MAC dues for group C & D employees after completion of his/her qualifying service for ACP/MACP in the Lakshadweep Administration for the last 6 years and also furnish name & designation of the officer who held the charge of the department during the above period and reason for non consideration for ACP/MACP
6. Furnish No. of DANICS Officers served in the Lakshadweep Administration for the last 6 years and those who have dues for his next higher grade after completion of his/her qualifying service in the present grade for the last 6 years.
7. Furnish entire department wise details regarding pending ACRs for group C & B employees in the Lakshadweep Administration for reporting/reviewing for the last 5 years and furnish name & designation of the reporting/reviewing officer of the ACRs and reason for not reporting/reviewing in time

Furnish whether the DANICS officers who posted in the Lakshadweep Administration are entitled for Air Condition facility, Television facility, Dish Television facility, mobile facility, Cook facility in their quarter/Room on government expenditure. If no, furnish reasons for providing the above facilities to them and also furnish the name &


designation of the authority who are provided with the above facilities and furnish the competency of the above authority.

9. Furnish No. of Disciplinary/Criminal cases pending against government servants in the Lakshadweep Administration for the last 6 years
10. Furnish No. of Disciplinary/Criminal cases filed by Vigilance in the Lakshadweep Administration against government employees for the last 6 years and also furnish name & designation of each employee and date of FIR
11. No. of Representations/Applications received by the Administrator, U.T. of Lakshadweep from employees side/employees association side for the grievances of employees for the last one year and also furnish action taken on each case by the Administrator
12. Furnish reasons for non filling of the post of Director (Fisheries), Director (Agriculture), Director (Education), Director (Animal Husbandry), Port Officer (Port Department), Manager (Lakshadweep Government Press) and Coconut Development Officer (Agriculture Department) in the Lakshadweep Administration and also furnish whether qualified hands are not available in the feeder cadre in the department or promotion not provided in the RR of the post for feeder cadre.
