APPLICATION UNDER SECTION 6 OF RTI ACT


Sri Ram Mohan Agarwal, husband of the applicant joined Indian Administrative Service in the year 1954 and retired on 31.07.1988 on completion of 58 years of age. His date of birth is 02.07.1930. At the time of retirement he was in receipt of pay equivalent to Secretary Government of India which was then Rs. 8000/- fixed w.e.f. 01.08.1988. His present pension and after his death which took place on 01.03.2008, applicant's pension has not been correctly fixed as such following information is necessary for revision of his pension, w.e.f.

01.01.2006 and also fixation of applicant's pension being his widow. You are therefore requested to provide the following information.

1. What post did Late Ram Mohan Agarwal held at the time of his retirement and what was his basic salary?
2. What was the basic salary on which pension of Late Ram Mohan Agarwal was fixed on his death?
3. Whether post of Chief Secretary Delhi Administration was upgraded from the rank of Additional Secretary to the Secretary to Government of India and since which date?
4. Whether during the period Late Ram Mohan Agarwal held the post of Chief Secretary, Delhi Administration, any of his juniors who joined Indian Administrative Service in the year 1954 and were junior to him were promoted to the rank of Secretary to the Government of India?
5. Whether pension of Late Ram Mohan Agarwal and on his death pension of the applicant was fixed w.e.f. 01.01.2006 in accordance to sixth pay commission which he was entitled as Secretary to Government of India?

6. Whether any revision of pension of Late Ram Mohan Agarwal and applicant (Smt. Kunti Devi Agarwal) was done, in accordance to Government Orders (O.M No. 45/86/97-P&PW(A)-Pt. I dated October 27, 1997, O.M No. 45/86/97-P&PW(A)-Pt. II dated October 27, 1997, O.M No. 45/86/97-Pt. III dated February 10, 1998 and O.M No. 45/86/97-P&PW(A)-Pt. IV dated May 8, 1998) issued by Government of India, Department of Pension.


