3. As regards your request for copies of the reports, it is stated that the two reports i.e. (i) J.S. Verma Commission of Inquiry report, in two volumes i.e. Vol.I & II bound in one single publication, and (ii) Report of Justice M.C. Jain Commission, in 9 volumes, are available in this Unit. These reports contain certain inputs from Central Security Agencies which are exempted under Section 24(1) of the RTI Act-2005 and cannot be disclosed. Excluding the pages, which are exempt as indicated above, the remaining parts of the Report containing about 1720 pages can be made available. You are therefore, requested to deposit a sum of total Rs.3440/- (@Rs. 2/- per page) as per provision of the RTI Act-2005, if you desire to have copies of the reports (excluding inputs from Central Security Agencies).
