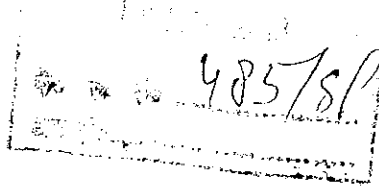

Hello,

Kindly provide me with the following information requested under the purview of the Right to Information Act, 2005.

**Regarding:** How Many Terrorists have been Charged and Punished For Murdering Soldiers in CI Ops since year 2000.

Our Military, Para Military and CPO have been involved in CI operation for long. These forces operate in disturbed areas under Armed Forces Special Powers Act. My request for information pertains to certain issues as asked below.

**Particulars of information required:** As per list mentioned below

1. How many soldiers/ personals from Military, Para Military and CPOs since 2000 to till now have been killed by terrorists while they were conducting counter insurgency operations in disturbed areas? Please provide details forces wise, rank and years wise giving separate list for J&K and NE?
2. Do these forces conduct CI operations under law of the land or CI operations are considered an act of war? Please clarify?
3. When these soldiers are killed by the terrorists in CI operation, is an offence of murder committed by them? If so then are any FIR being registered against terrorists? If so then please provide information of FIRs registered in form of a summary (numbers). Please provide such information forces and state wise?
- ④ How many terrorists since 2000 have been charged, convicted and punished (sentence awarded) for murdering the soldiers in CI Operations? Please provide information forces wise? ~~2013~~
5. How many soldiers from these forces have been punished for human rights violations? Please provide details forces wise?

  8. If not then what special arrangements have been made to ensure fair and efficient functioning of justice system in disturbed areas to punish convicted terrorists?


