

INFORMATION SOUGHT UNDER RTI ACT :

1. Under which Schedule, Part and Section of the Central Civil Services (Revised Pay) Rules, 2008 notified on 29th August, 2008, the salary of Adhoc DANICS who have been drawing Salary in the Pre-revised Scale of 6500-200-10500 as on 01.01.2006 and eligible for NFS of 8000-275-13500 w.e.f. 01.01.1996 (with financial benefits w.e.f. 01.12.2006), is being regulated ? Kindly provide the extracts of the relevant **Schedule, Part and Section** of the CCS (RP) Rules, 2008, **highlighting wherein the relevant entry** and specifying the Scale as well as Admissible Grade Pay applicable for them.
2. The following information may kindly be provided while considering the fact that the Adhoc DANICS officer had got the benefit of NFS of 8000-275-13500 w.e.f. 01.01.1996 (with financial benefits w.e.f. 01.12.2006), wherein the Grade Pay of Rs.5,400/- was duly considered w.e.f. 01.12.2006 for release of the pensionary benefits to him.
 - a. If the said Adhoc DANICS officer have actually drawn Grade Pay of Rs.4,800/- during 01.01.2006 till 31.10.2006, when he superannuated, what is the validity of an Order of the Government for reduction of Grade Pay to Rs.4,600/-, after his death in the year 2012 ?
 - b. What is the validity of the act of recovery by the Government due to aforesaid reduction in Grade Pay, from the dues payable to his family ?
 - c. Is the Grade Pay of a Administrative Officer equal to the Grade Pay of a Adhoc DANICS officer under CCS (RP) Rules, 2008 ?
 - d. Is the Grade Pay of a Superintendant equal to the Grade Pay of a Adhoc DANICS officer under CCS (RP) Rules, 2008 ?
 - e. If answer to any one out of 'c' or 'd' above is yes, kindly provide the extracts of the relevant **Schedule, Part and Section** of the CCS (RP) Rules, 2008, **highlighting wherein the relevant entry** and specifying the Scale as well as Admissible Grade Pay applicable for them.
 - f. If no, specify the **Schedule, Part and Section** of the CCS (RP) Rules, 2008, **highlighting wherein the relevant entry** and specifying the Scale as well as Admissible Grade Pay applicable for a Administrative Officer as well as for the Superintendent.
