Sh. Subhash Gosai has preferred an appeal dated 20.11.2013 stating that he has not been furnished correct point wise information of his RTI application dated 27.09.2013.

- Sh. Subhash Gosai in his application dated 27.09.2013 sought information on 3 points to which the applicant was replied vide this ministry's letter dated 24.10.2013
- 3. In r/o of information sought vide point no (1) & (2), since there was no record of file movement and also letters dated 09.04.2012 & 14.09.2012 were not found placed in the concerned file of UTS-I desk, the CPIO in order to ensure transparency replied the applicant to visit the UTS-I section for inspection of records and for point no (3) the applicant was informed that payment (if any) will be made by the competent authority as per laid down procedure and rules vide this ministry's letter dated 24.10.2013.
- 4. The appeal filed by Sh. Subhash Gosai has been carefully considered and it is found that the aforesaid reply of the CPIO with reference to his RTI application dated 27.09,2013 is in conformity with the Right to Information Act, 2005. However the applicant is informed that the payment of bill is under process and will be made as per laid down procedure and rules.

5. The appeal is accordingly disposed of.

That PIO rather replying the questions pointwise and send a wrong and baseless reply in order to create ambiguous situation, knowing the fact that the request of the applicant was not to inspect the records, however, the same is not in the spirit that PIO may provide file movement datewise, reply to representation dt. 09.4.2012 and 14.9.2012 and of making payment of bill.

In view of above, petitioner submit this appeal to the Ist Appellate Authority under RTI Act to reply my application dated 27.9.2013 in correct manner pointwise to the points raised down fit and proper and payment of bills at earliest.
