Point no. 1, 5, 7 & 8:- Application may be forwarded to the Delhi Police under section 6 (3) of the RTI Act, 2005 to provide reply to reference to these points.

Point no. 2 & 3:- The matter regarding reservation of posts in promotion of Inspector to ACP is subjudice. Therefore, requisite information cannot be provided as of now as it is dependent on outcome of the Court Case.

Point no. 4 & 6:- As per DANICS Rules, 261 cadre posts of ACsP are in the Delhi Police.

Point no. 9:- The information asked by the applicant is not covered under the RTI Act, 2005. However, it is stated that appropriate steps are being taken to fill the existing vacancies as per due procedure.
