
Please refer to your online RTI application No. MHOME/R/2014/61526 dated 30.06.2014 received in this office on 25.07.2014.

2. In this regard, it is informed that during the period from 1980 to 2014 (upto 15<sup>th</sup> July) [excluding 1986], 3061 security personnel, 12015 civilians and 4724 naxals were killed. 146 deaths were reported during 1986 but bifurcated data of deaths (SFs and civilians) is not available in this regard.

3. As regards point no. 4, it is informed that 'Police' and 'Public Order' being State subjects, action with respect to maintenance of law and order lies primarily in the domain of the State Governments concerned. The Central Government has four pronged strategy to tackle LWE menace – Security Related Measures; Development Related Measures; Ensuring Rights & Entitlements of local communities and public perception Management, wherein it supplements the efforts of the State Governments. In the security related interventions, the Central Government supplements the efforts of the State Governments over a wide range of issues including deployment of CAPFs, assistance in implementation of development schemes, improving governance and capacity building by the States in various areas. It is the belief of the Government of India that a combination of calibrated police action, focused development efforts and improvement in governance will yield the desired results against LWE.

4. As regards points nos. 2, 3, & 4, your application is being forwarded to Shri Deepak Kumar Kedia, Director (LWEO-II), Shri Rambir Singh, Director (LWE-I), Shri K. S. Kusala Kumar, Director (LWE-II) and Shri Ashish V. Gawai, Under Secretary, Ministry of Home Affairs, New Delhi.


