- 6. 42nd Induction Training Course has been successfully completed at SVP NPA for the newly inducted IPS officers and were relieved from Academy on 1.10.2021 to report to their parent cadres.
- 7. On 25.10.2021, a meeting of the SRE Committee was held under the Chairmanship of Special Secretary (IS) to finalize Annual Work Plan (AWP) 2021-22 under the Security Related Expenditure Scheme for the States Jharkhand and Madhya Pradesh.
- 8. On 26.10.21 a meeting was held under the Chairmanship of Special Secretary (IS) to review the progress of setting up of the Integrated Control Room for Emergency Response (ICR-ER)
- 9. A PCC virtual meeting was held by Additional Secretary (LWE) on 04.10.2021 to discuss the proposal of Government of Telangana regarding modification in the works approved earlier.

- 18. Sanction of Rs.13.73 Crore for procurement of items under Swachhata Action Plan (SAP) for financial year 2021-22 for Assam Rifles on 08.10.2021.
- 19. 150 posts have been created in Fire Wing in Unit BSL Bokaro, Jharkhand on 04.10.2021.
- 20. Meeting of EFC was held on 27.07.2021 for continuation of Central Sector Scheme viz. BSF Air Wing, Aircraft, Riverboat & Heli-base with an estimated outlay of Rs.732.05 crore and sanction was issued on 01.10.2021.
- 21. On 29.09.2021, Govt. has approved proposal for transfer of 1.203 hectare land of CRPF at Ayodhya (Uttar Pradesh) to Public Works Dept. of Govt. of UP for construction of approach road to Govt. - 26. Sanction for prosecution for filing the charge sheet against 06 Accused persons was accorded with section 45(1) of the Unlawful Activities (Prevention) Act, 1967.
- 27. On 28.10.2021, orders under section 10(2) (1) of the Disaster Management Act, 2005, were issued extending the validity of the order dated 28.9.2021 directing the State/UT Governments and State/UT Authorities to consider implementation of Prompt & Effective Containment Measures, as conveyed vide MoHFW advisory dated 21st September, 2021. This Order will remain in force until 30.11.2021.
