Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of September, 2021.

Hon'ble Home Minister presided over the signing of a historic agreement between Government of India, Government of Assam and representatives of Karbi Groups (KLNLF, PDCK, UPLA, KPLT) on 04.09.2021 at New Delhi, to end the decades old crisis in Karbi Anglong area of Assam. With this historic agreement, over 1000 armed cadres have abjured violence and joined the mainstream of society. A Special Development Package of Rs. 1000 crores over five years will be given by the Union Government and Assam Government to undertake specific projects for the development of Karbi areas.

- 2. Hon'ble Home Minister also held a meeting with Chief Minister of Tripura on 01.09.2021 at New Delhi to review the progress of implementation of Bru agreement.
- 3. A Ceasefire Agreement with National Socialist Council of Nagaland (K) Niki group was signed on 08.00.2021 for a period of one year and more than 200 cadres of this group along with 83 weapons joined the peace process
- 4. SoO agreements with United Peoples' Front [UPF] and Kuki National Organization [KNO] of Manipur have been extended for a further period of six months w.e.f. 01.09.2021 to 28.02.2022.
- 5. Hon'ble Home Minister held a meeting on 26.09.2021 to review the LWE scenario with Union Ministers, Chief Ministers, Secretaries of Central Ministries, Chief Secretaries and DsGP of the LWE affected States.
- 6. On 13.09.2021, Union Home Secretary had also reviewed the LWE scenario with DIB and DG (CRPF).
- 7. On 17.09.2021, Union Home Secretary held a meeting with the representatives of D/o Telecommunication, Finance Secretary & Secretary Expenditure, M/o Rural Development, M/o Road Transport & Highways, M/o Tribal Affairs and D/o Posts to review the progress and current Status of the developmental initiatives undertaken for the LWE affected areas.
- 8. Union Home Secretary had written a D.O. letter on 18.09.2021 to the Chief Secretary, Maharashtra regarding the progress in RCPLWEA.
- 9. Further on 18.09.2021, Union Home Secretary had written to all LWE affected States to sensitize them on various issues.

- 10. A meeting (Video Conference) of the SRE Committee was held on 14.09.2021 under the Chairmanship of Special Secretary (IS) to finalize Annual Work Plan (AWP) 2021-22 under the Security Related Expenditure Scheme for the States Bihar, Kerala, Odisha and West Bengal.
- 11. A VC was held on 01.09.2021 by Additional Secretary (LWE) to review the progress/status of Joint Task Force (JTF) camps approved under Assistance of Central Agencies for LWE Management Scheme (ACALWEMS) with the representatives of CRPF, Home Deptt. of Chhattisgrh, Telangana Jharkhand and IB.
- 12. On 06.09.2021 and 07.09.2021, Additional Secretary (LWE) held meetings to review the progress of developmental scheme in LWE affected States with the representatives of M/o Skill Development & Entrepreneurship & M/o Tribal Affairs. Further, a VC was held on 14.09.2021 by AS (LWE) to discuss the issues of flow of funds to the LWE cadres/other. LWE groups operating in LWE affected areas.
- 13. A total of Rs. 18.84 crore released to CRPF, BSF, ITBP & SSB under Civic Action Programme in LWE affected areas. A total of Rs. 71.71 crore released to Andhra Pradesh, Chhattisgarh, Madhya Pradesh, Maharashtra & Telangana States under Security Related Expenditure (SRE) Scheme.
- 14. One Advisory has been issued to State Government/CAPFs to sensitize them to counter the LWE activities in the LWE affected areas.
- 15. Total 226 Coys of CAPFs were deployed in various states/UTs (i.e. Uttar Pradesh, Gujarat, Maharashtra, Telangana, Bihar, Haryana, Meghalaya, Odisha, West Bengal, Delhi and Andaman & Nicobar) for law and order duties. Further, approval has been given for deployment of 407 CISF personnel on IS duty pattern from 15.09.2021 to 19.09.2021 for providing security during India International Jewellery Show at Bangalore International Exhibition Centre, Karnataka.
- 16. EFC in its meetings on 27.07.2021 has approved the proposals for continuation of Central Sector Scheme viz. BSF Air Wing, Aircraft, Riverboat & Helibase with an estimated outlay of Rs.732.05 crore and continuation of Umbrella Schemes of Police Infrastructure Building Project of DAPFs, CPOs and Delhi Police beyond 31.03.2021 with an outlay of Rs.21087.11 crore.
- 17. Sanction for prosecution for filing the charge sheet against 49 accused persons was accorded in accordance with section 45(1) of Unlawful Activities (Prevention) Act, 1967.

- 18. 2278.114 Kgs Narcotics substance alongwith 72291 bottles of LSD, 605 bottles of Pseudoephedrine, 9000 Tablets of Zolpidem and 8000 Tablets of Tramadol was seized in September, 2021. Total 68 persons were arrested for their involvement in drug trafficking during the month under report.
- 19. Mutual Legal Assistance Treaty in Criminal Matters with Belgium has been signed on 16.09.2021 at Egmont Place, Brussels.
- 20. On 28.09.2021, order issued under the Disaster Management Act, 2005, regarding implementation of prompt and effective containment measures for COVID-19 management, as conveyed vide MoHFW advisory dated 21.09.2021 until 31.10.2021. Thereafter, I wrote to all Chief Secretaries and Administrators of States/UTs to ensure compliance and take necessary measures for proper implementation of the advisory issued by MoFHW
