Sub:-New Scheme for payment of freedom fighters pension w.e.f. 1.1.90 - simplification of procedure.

Sir,

I am directed to refer to the correspondence resting with your office U.O. Nos. 10-279/CPAO/89/376 dated 19.2.90 and 10-279/CPAO/89-560 dated 16.3.90 regarding introduction of new scheme for payment of freedom fighters' pension and to say that as per decision of the Ministry of Finance (Deptt. of Expenditure) (Central Pension Accounting Office) communicated vide this Ministry's letter of even number dt. 15.1.1990, all the sanctions issued by this Ministry on or after 1.1.1990 are to be conveyed to the Chief Controller of Accounts, Ministry of Home Affairs, New Delhi, for arranging payment and accounting of Central Civil Pension. Difficulties are, however, being experienced by various quarters in the matter of transfer of pensions to spouse/dependent daughters, ante-dating, suspensions / cancellation and restoration of pension in which orders for sanction of pension were issued by this Ministry before 1.1.1990. The matter has been under consideration for sometime past and it has been decided in consultation with the Ministry of Finance, (Deptt. of Expenditure) (Central Pension Accounting Office) that such type of cases may henceforth be dealt with as per the procedure laid down below:

1. Transfer of pension to spouse/ dependent daughters:

(a) where pension has been sanctioned family to freedom fighters on or after 1.1.90 and the name of spouse is also included in the

and the name of spouse is also included in the sanction letter issued by this

Ministry, family pension in such cases will be authorized by PAO (Sectt.), M.H.A. After the death of the pensioner the spouse /unmarried dependent daughters will submit an application along with death certificate and other identification documents for herself/ himself to the pension disbursing authority. Pension Disbursing Authority will commence the payment of pension to the spouse/unmarried dependent daughters after getting the claim verified w.r.t. identification documents and joint photograph submitted earlier by deceased freedom fighter.

- (b) Where pension has been sanctioned to the freedom fighter on or after 1.1.90 and the freedom fighter has since expired before or after drawing the pension for some period and where name of the spouse was not included in the sanction letter/PPO, the Freedom Fighter's Division, Ministry of Home Affairs shall, on receipt of a request from spouse/unmarried dependent daughters, call for his/her verification report from the District Magistrate concerned. After receipt of verification report such cases will be processed as fresh ones and necessary sanctions addressed to the Chief Controller of Accounts, Ministry of Home Affairs for issuing fresh PPOs.
- (c) Where pension has been sanctioned to freedom fighters before 1.1.90 and the freedom fighter has since expired before or after drawing the pension for some period and where the name of the spouse was not included in the sanction letter/PPO, the Freedom Fighters' Division, Ministry of Home Affairs shall, on receipt of a request from spouse/unmarried dependent daughters, call for his/her verification report from the District Magistrate concerned. After receipt of verification report, such cases will be processed as fresh ones and necessary sanctions addressed to the Chief

Controller of Accounts, Ministry of Home Affairs, for issuing fresh PPOs. In such cases the old sanctions/PPOs will have to be cancelled.

The cases of payment of pension to widows where pension was sanctioned to the freedom fighter after his death and the fact that the freedom fighter is dead, was not known to this office, have also to be processed as fresh ones, as explained above.

- (d) Where pension has been sanctioned to freedom fighter before 1.1.1990 and the name of the spouse was also included in the sanction letter PPO and the freedom fighter has since expired after drawing it, in such cases, Freedom Fighters' Division, Ministry of Home Affairs shall on receipt of the intimation about the death of the freedom fighter, process the case as fresh one and deal it on the same lines as at para 1.1 (c) above and issue necessary sanction to the Chief Controller of Accounts, Ministry of Home Affairs for issuing of fresh PPOs.
- (e) Where pension has been sanctioned to a widow on or after 1.1.1990 as a fresh case, naturally sanctions are to be conveyed to the Chief Controller of Accounts, Ministry of Home Affairs.
- 1.2 Ante-dating/ suspension/ cancellation/ restoration of pension:

In such cases where orders have been issued be before 01.01.1990, all further orders for their ante-dating suspension/cancellation/restoration of pension will be conveyed to the concerned Accountant General under intimation to the Central Pension Accounting Office.

1.3 Procedure for switch-over for

If a freedom fighter pensioner who has been sanctioned pension before 1.1.1990 intends

payment of pension from Treasury to Sector Banks to switch over from Treasury to Public Sector Banks, for payment of pension, he/she will Public submit the application (in duplicate) in

the enclosed prescribed proforma to the Treasury Officer concerned.

The pensioners should first draw pension which has already fallen due, before applying for transfer of their pension papers to the public sector banks.

Transfer applications (in duplicate) shall be forwarded immediately by the Treasury Officer along with the copies of the disbursor's halves (duly authenticated and written upto-date) of the related PPOs to Central Pension Accounting Office for transmission to the link branches of the public sector banks for arranging payments after keeping necessary note in their records, invariably under intimation to the Accountant General concerned and the Freedom Fighters' Division, Ministry of Home Affairs. Action will also be taken by Treasury Officer to up-to-date the entries of payment made in the pensioner's half of the PPOs, if not already done before the transfer applications are sent to the Central Pension Accounting Office.

2. All concerned are requested to take necessary steps to bring into force the contents of this letter with immediate effect.

New Scheme for payment of freedom fighters' pension with effect from 1.1.90 - simplification of procedure amendments - regarding.

Sir,

I am directed to refer to this Ministry's letter of even number dated 24<sup>th</sup> October, 1990 on the subject mentioned above and to say that several requests are being received in this Ministry of simplifying the procedure for obtaining the pension by the legal heirs (spouses and unmarried dependent daughters) of the deceased freedom fighters who were in receipt of the Swatantrata Sainik Samman Pension. Accordingly, the matter has been carefully considered and it has been decided to make certain modifications in respect of the procedure laid down against some of the items contained in the aforesaid letter. Accordingly, the following modifications are made:

- (1) Paragraphs 1.1.(b), 1.1.(c) and 1.1(d) may be deleted.
- (2) New paragraphs namely 1.1(b) (i) and 1.1(b) (ii) may be substituted below para 1.1(a) as given under:-

### <u>Paragraph 1.1 (b) (i )</u>

'In case of pensioners already drawing their pension through the Public Sector Banks/Director of Accounts/ Treasuries/Pay & Accounts Officers, payment of family pension as indicated in the Pension Payment Orders shall be commenced by the disbursing officers on receipt of death

certificate and application for family pension in the prescribed forms along with pensioner's portion of the Pension Payment Order. The disbursing officer will enter the date of death of the pensioner in the disburser's portion of the Pension Payment Order and also make entries in the pensioner's portion of the Pension Payment Order. Before commencing payment of family pension, the disbursing officer will take action for identification of the family pensioner as prescribed in the rules. The date of death of the pensioner will also be intimated to the Freedom Fighters' Division, Ministry of Home Affairs and Central Pension Accounting office by pension disbursing authorities. The disbursing officer will also be responsible for obtaining certificate of remarriage/non-marriage and non-employment certificate in case of daughters from the recipient.'

#### Paragraph 1.1 (b) (ii)

'In cases where nomination does not exist, the disbursing officer may make payment of family pension after obtaining an affidavit affirming dependents relationship to the freedom fighter. A passport size photograph of the dependent of the freedom fighter should be, affixed on the affidavit which may be duly verified and attested by the District Magistrate under his office seal.'

- (3) Paragraph 1.1(e) may be renumbered as paragraph 1.1 (c)
- 2. All the concerned are requested to take necessary steps to bring into force the contents of this letter with immediate effect.
