Subject: Transfer of the work relating to the Administration, Management and disposal of the remaining undisposed of assets of the Settlement Organisation in Bihar to the State Government.

Sir,

I am directed to state that the question of administration, management and disposal of the remaining undisposed of the acquired evacuee lands/properties/Government built properties and realisation of arrears of rental demands and other dues outstanding against individuals in respect of evacuee properties in Bihar has been under consideration of the Government of India for some time past.

- 2. It has been observed that only a limited number of acquired evacuee agricultural lands/properties and Government built properties remain to be disposed of.
- In additiom to the above, arrears on account of rent of rural and urban evacuee properties which run into a considerable amount have become long overdue for recovery and their realisation is presenting considerable difficulty.
- 4. With a view to effecting economy in expenditure and ensuring proper arrangement for the administration, management and disposal of acquiredevacuee lands/properties, Government built properties and recovery of rent of rural and urban evacuee properties and other outstanding dues, tit has been decided in the public interest to transfer the aforesaid items of work to the State Government of Bihar for disposal of residuary work in a satisfactory manner and for carrying out the purposes of the Displaced Persons (Compensation & Rehabilitation) Act, 1954 and the Rules framed thereunder.

President of India to the administrative and financial arrangements being made with the Government of Bihar for the administration, management and disposal of the residuary assets of the Settlement Organisation in the State of Bihar as per details given below:

(i) The work relating to administration,
management and disposal of the remaining

and agricultural lands shall stand transferred to the Government of Bihar with
effect from the 1st March, 1977. The State
Government shall administer, manage
and dispose of these lands/properties to
the best advantage of the Government and
credit the sale proceeds to the State Head
of Account. Full details of the/properties
are given in Annexure

- (ii) The work relating to recovery of arrears of rent of both acquired and unacquired evacuoe properties was entrusted to the State Government of Bihar on an agency basis in terms of Government of India's letter No.16(18)/L&R/65, dated 30-3-66, on payment of commission charges by the Government of India to the Government of Bihar @ 10% of the actual realisation made. Since the Government of India have decided to divest themselves fully of this responsibility in the State of Bihar, the work relating to recovery of arrears of rent shall stand transferred to the State Government with effect from 1st March, 1977. The State Government shall t ake effective steps to recover these arrears of rent from the tenants and credit the amounts thus recovered to the State Head of Account. In cases where recoveries cannot be made despite suitable steps taken by the Sate Government in this behalf, the arrears of rent would be written off.
- All expenditure in connection with the administration, management and disposal of the lands/properties and recovery of arrears of rent etc. shall be borne by the State Government and the realisation made by them from the disposal of the lands/properties/and recovery of arrears of rent shall be credited to the State Head of Account.

7. The State Government shall pay a token sum of Rs.1/- (Rupee one) only to the Central Government. The payment will be made by draft to the Deputy Controller of Accounts (Rehabilitation), New Dehi for credit to the account of :

" O88-Social Security and Welfare-Relief and Rehabilitation of Displaced Persons-Displaced Persons from former West
Pakistan- Receipts forming part of Compensation Pool-Receipts on account of acquired evacuee property."

8. Relevant records pertaining to the agricultural lands, built up properties and recovery of arrears of rent etc. shall be transferred by the Deputy Chief Settlement Commissioner (G), Department of Rehabilitation, to the Government of Bihar by 28th February, 1977, at the latest.
