MONTHLY SUMMARY FOR THE CABINET FOR THE MONTH OF JUNE, 2018.

PART-I UNCLASSIFIED

A Government of India Delegation, led by Union Home Minister, visited Mongolia from 21-24 June, 2018. The Delegation had bilateral meetings with Hon'ble Minister of Justice and Home Affairs and Hon'ble Deputy Prime Minister of Mongolia. The Petrochemical Refinery Project in Mongolia, under Government of India's Line of Credit, was inaugurated by Hon'ble Home Minister in a Ground Breaking Ceremony during the visit.

- 3. On 29.06.2018, High Level Committee (HLC) Meeting was held under the Chairmanship of Union Home Minister for Central Assistance to the States of Andhra Pradesh, Arunachal Pradesh and Nagaland for flood/landslides- 2017 and Andhra Pradesh for drought (Rabi) of 2017.
- 4. A meeting was held on 22.06.2018 under the chairmanship of Sh. Kiren Rijiju, MoS (R), Ministry of Home Affairs to review the progress of border infrastructure proposal along the Indo- China border.
- 5. 16th Meeting of National Committee on Strengthening Maritime and Coastal Security (NCSMCS) against threats from the sea was held on 29.06.2018 under the Chairmanship of Cabinet Secretary.
- 6. On 28.6.2018, Union Home Secretary held a meeting of the 44th High Level Empowered Committee (HLEC).
- 7. Expenditure Finance Committee (EFC) Meeting for construction of 13 ICPs and Passenger Terminal Building at ICP, Petrapole was held on 11.06.2018 under the Chairmanship of Expenditure Secretary.
- 8. The State of Nagaland has been declared as "Disturbed Area" under the Armed Forces (Special Powers) Act, 1958 for a period of six months w.e.f. 30.06.2018 i.e.upto 31.12.2018.
- 9. Suspension of Operation (SoO) agreements signed with National Democratic Front of Bodoland (Progressive) [NDFB(P)] and National Democratic Front of Bodoland (Ranjan Diamary) [NDFB(RD)] have been extended for six months i.e. upto 31.12.2018.
- 10. Union Home Secretary wrote to the Chief Secretaries of 4 LWE affected States for speedy and timely completion of pending works released to State Governments under the Road Requirement Plan-I (RRP-I).
- 11. The Home Secretary also wrote letters to Director Generals of CAPFs and Director Generals of Police of LWE affected States sharing best practices of C-60 of Maharashtra in the backdrop of success achieved by them.

13. It has been decided with the approval of the Competent Authority to exclude 29 inhabited islands in the Union Territory of Andaman & Nicobar Island from the Restricted Area Permit regime notified under the Foreigners (Restricted Areas) Order, 1963 till 31.12.2022.

- 14. During the month, an amount of Rs. 63.47 crore was released to the State Government of Nagaland, Sikkim, Meghalaya and Mizoram. The total funds released under Border Area Development Programme (BADP) so far during the financial year 2018-19 works out to Rs.162.61 crore.
- 15. This Ministry contributed towards holding of Conference of Governors at Rashtrapati Bhavan on 4 5 June, 2018.
- 16. An amount of Rs. 88.62 crore was released to LWE affected states as reimbursement under the Security Related Expenditure scheme.
- 17. Central Government has designated 'Al-Qaeda in the Indian Subcontinent' (AQIS) and Islamic State in Khorasan Province (ISKP)/ ISIS Wilayat Khorasan/Islamic State of Iraq and the Sham-Khorasan (ISIS-K) as terrorist organisation involved in terrorism in the First Schedule of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967).
- 19. A total number of 220 Coys of CAPFs were deployed in various States for maintaining law and order duties and security arrangements for AmarnathYatra 2018, Eid-ul-Fitr, International Day of Yoga, area domination and road sanitization during visits of VVIPs and various festivals.
- 20. CCTNS software has been deployed at 15546 out of 15640 Police Stations across the country, i.e. 99.39%. Around 14243 Police Stations out of 15640 Police Stations are entering 100% FIRs through CCTNS, i.e. 91.06%.
- 21. All States/UTs have launched their State Citizen Centric Portals.
- 22. Out of Total outlay of the Project of Rs 2000 crore, Rs. 1796 crore have been released till date to States/UTs and Central Agencies.
- 23. The President of India gave assent to 7 State Bills namely the Court Fees (Jharkhand Amendment) Bill, 2017, the Indian Penal Code and Code of Criminal Procedure (Maharashtra Amendment) Bill, 2017, the Chhattisgarh Nagar Tatha Gram Nivesh (Amendment & Validation) Bill, 2017, the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement (Jharkhand Amendment) Bill, 2017, the Assam Witch Hunting (Prohibition, Preservation & Protection) Bill, 2015, the Rajasthan Land Pooling Schemes Bill, 2016 and the Karnataka Extension of Consequential Seniority to Government Servants Promoted on the basis of Reservation (to the posts in the civil services of the State) Bill, 2017, during the month.

- 24. During the month, the Narcotics Control Bureau seized large quantities of heroin, ganja, opium, cocaine and other narcotics and arrested 45 persons in connection with drug trafficking.
- 25. Two RRs for the post of Multi Graph Operator and Chief Drill Instructor of SVP NPA have been published.
