Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of June, 2019.

Hon'ble Home Minister, Shri Amit Shah chaired a high level meeting on 11.06.2019 of State and Central Ministries/Agencies concerned to review the preparedness to deal with the situation arising out of Cyclone VAYU'.

- 2 A Memorandum of Understanding between National Security Guards (NSG) and National Guards of the Armed Forces of the Kyrgyz Republic was signed on 14.06.2019 during Hon'ble Prime Minister's visit to Kyrgyz Republic.
- 3. Union Home Secretary wrote to the Chief Secretaries of Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Telangana, Kerala and West Bengal to have a detailed review of LWE scenario with their Director Generals of Police and other Officers.
- 4. Secretary (BM) held a meeting on 17.06.19 with the Nehru Yuva Kendra Sangathan to discuss the revised proposal for 12th Tribal Youth Exchange Program under Media Plan for LWE affected areas.
- 5. A meeting was held under Special Secretary(IS) on 20.06.19 with CRPF, Department for Promotion of Industry & Internal Trade and the Petroleum and Explosives Safety Organization to discuss monitoring and control over explosives by using technology to prevent leakage and misuse.
- 6. An amount of Rs. 93.66 crore was released to LWE affected States as reimbursement under the Security Related Expenditure Scheme.
- 7. 03 advisories were issued to the State Government / CAPFs to sensitize them on activities of Left Wing Extremists in the LWE affected areas.
- 8. The President of India gave assent to 3 State Bills namely, The Code of Criminal Procedure (Uttar Pradesh Amendment) Bill, 2018, The Industrial Disputes (The Tamil Nadu Amendment) Bill, 2018 and The PEPSU Tenancy and Agriculture Lands (Haryana Amendment) Bill, 2017.
- 9. Sanction for prosecution for filling the charge sheet against 44 accused persons was accorded under the Unlawful Activities (Prevention) Act, 1967 for terrorist and anti-national activities.

- 10. Rs. 10.71 crore has been released towards Assistance to State for Modernization of Police.
- 11. For disseminating the Information Security Best Practices, a booklet has been released and made available on MHA website.
- 12. 106 Coys of CAPFs were deployed in Uttar Pradesh, Delhi, Punjab, Telangana, Bihar, Jharkhand, Gujarat, Odisha, Jammu and Kashmir for Al vida ki Namnz and Id-Ul-Fitra, law and order duties in Ayodhya, security arrangements in the context of swearing-in ceremony of Hon' ble Prime Minister of India, security of outer periphery of the Parliament. During Parliament Session from 16.06.2019 till conclusion of the Parliament Session, law and order duties in connection with the International Day of Yoga, Ghallughara Week in Punjab, Friday Prayer in Hyderabad City, Annual Jagannath Rathyatra (Car festival), and Sindhu Darshan festival in Leh.
- 13. Rs. 315.21 Crore has been sanctioned for development of infrastructure to the CAPF.
- 14. An amount of Rs. 2970.48 lakh has been released to the State Governments of Mizoram and Nagaland under BADP.
- 15. On 24th June 2019, Cabinet approved the proposal to reintroduce the Protection of Human Rights (Amendment) Bill, 2019 to amend the Protection of Human Rights Act, 1993.
- 16. 4th Meeting of Monitoring Committee to coordinate for implementation of the Agreement signed on 3.7.2019 for repatriation of Bru families from Tripura to Mizoram was held under Special Secretary (IS), on 28.06.2019 at New Delhi.
- 17. The whole State of Nagaland has been declared as 'disturbed area' under the Armed Forces Special Power Act, 1958 vide Notification No. S.O. 2261(E) dated 30.6.2019 for a period of six months w.e.f. 30.06.2019.
