## Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of October, 2018.

Union Home Minister held a meeting on 10.10.2018 to discuss the proposals of the State Governments relating to grant of ST/SC status to various communities of Arunachal Pradesh, Assam, Maharashtra, UP, Himachal Pradesh, MP, Goa and Kerala.

- 2. A Government of People's Republic of China (PRC) Delegation led by Mr.Zhao Kezhi, Hon'ble Minister of Public Security met the Gol delegation led by Hon'ble Union Home Minister on 22.10.2018 for the 1<sup>st</sup> High Level Meeting on Bilateral Security Cooperation between Republic of India and People's Republic of China. An "Agreement on Cooperation " between the two countries was signed.
- 3. The Union Home Minister met the then Prime Minister of Sri Lanka, Mr. Ranil Wickremesinghe, on 19.10.2018. Matters of mutual interest concerning the two countries were discussed.
- 4. On 08.10.2018, Shri Kiren Rijiju, MoS (H) held a meeting to discuss the status of various issues relating to North Eastern Region.
- 5. The 22<sup>nd</sup> National Level Meeting between India and Myanmar took place on 25 26<sup>th</sup> October, 2018 under the Chairmanship of Union Home Secretary. The Myanmar delegation was led by Major General Aung Thu, Deputy Minister, Ministry of Home Affairs, Government of the Republic of the Union of Myanmar. In the meeting, cooperation on internal security, management of international borders, cooperation in prevention of Drug Trafficking, Wildlife smuggling and issues of mutual concerns were discussed.
- 6. On 29.10.2018, Union Home Secretary held the 45<sup>th</sup> meeting of the High Level Empowered Committee (HLEC).
- 7. National Liberation Front of Tripura (NLFT) and All Tripura Tiger Force (ATTF) of Tripura have been declared as 'Unlawful Associations' under Section 3 (1) of the Unlawful Activities (Prevention) Act, 1967 vide Notification No. 5078 (E) dated 3.10.2018.
- 8. A Meeting of the Sub-Committee of National Executive Committee (SC-NEC) was held under the Chairmanship of Union Home Secretary on 11.10.2018 for Central Assistance to the State of Tripura and on 18.10.2018 for the State of Karnataka for flood/landslides -2018.
- 9. The President of India gave assent to 4 State Bills namely the Gujarat Scheduled Castes, Scheduled Tribes and other Backward Classes (Regulation of Issuance and verification of caste certificates) Bill, 2018, the Tamil Nadu Forest (Amendment) Bill, 2018, Gujarat Prevention of Fragmentation and Consolidation of Holdings (Amendment) Bill, 2018, the Code of Civil Procedure (Maharashtra Amendment) Bill, 2018 during the month.

- 10. A total number of 54 Coys of CAPFs were deployed in various States for maintaining law and order during Dussehra Festivals and Friday Prayer, Moharrum, visit of VVIP, at Satlok Aashram, Barwala, Hisar.
- 11. On the recommendations of ECI, 40 Coys of CAPFs were deployed for the Bye-Election in Karnataka State. On the recommendations of ECI, 785 Coys of CAPFs were deployed for Assembly Election in Rajasthan, Madhya Pradesh, Chhattisgarh, Mizoram and Telangana State.
- 12. 100 ITBP Commandos were provided to Delhi Police during 19 21<sup>st</sup> October 2018 for security arrangements during the visit of VVIP in Delhi.
- 13. 04 advisories were issued to the State Government / CAPFs to sensitize them to counter the LWE activities in LWE affected areas.
- 14. CCTNS software has been deployed at 14710 out of 14761 Police Stations across the country excluding the State of Bihar, i.e. 99.65%. Around 14659 Police Stations out of 14761 Police Stations are entering 100% FIRs through CCTNS excluding State of Bihar, ie.99.3%.
- 15. Data digitization of 3.89 crore records has been completed, i.e. 99.32% of the total target.
- 16. Out of total outlay of the project of Rs.2000 crore, Rs.1802.5 crore have been released till date to States/UTs and Central Agencies.
- 17. Extension of the Societies Registration (Goa, Daman & Diu First Amendment) Act, 1979 and the Societies Registration (Goa Second Amendment) Act, 1998 to UT of Dadra & Nagar Haveli was issued vide Notification dated 18.10.2018.
- 18. The complete draft National Register of Citizens (NRC) in Assam was published on 30.07.2018 and Standard Operating Procedure (SOP) for the next stage of the exercise i.e. claims and objections was prepared by the Central Government in consultation with the State Government, RGI and the State Coordinator and the same was filed in the Hon'ble Supreme Court. The SOP filed by Union of India has been approved by the Supreme Court vide its order dated 01.11.2018.
- 19. The process of receipt of claims and objections on draft NRC began from 25.09.2018 and will remain open upto 15.12.2018 in accordance with the directions of Supreme Court. After digitization and compilation of all formalities and requirements, notices will be issued by 15.01.2019 and verification process will commence from 01.02.2019.
- 20. NRC will be finalized only after the disposal of claims and objections and timelines are approved by the Supreme Court.
