## Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of September, 2019.

On 24.09.2019, Hon'ble Home Minister launched the 'Private Security Agency Licensing Portal' relating to issue of online license to private security agencies. The Portal provides for common platform for making online applications and issue of licenses/renewal of licenses for all States/UTs. Antecedents check is done online through ICJS, and facility of online payment of fees has been made available by integration of payment gateway of all States/UTs. E-sign and geo-tagging features have also been provided on the Portal.

2. On 24.09.2019, Hon'ble Minister of State, Shri G. Kishan Reddy launched the public awareness Media Campaign for hiring licensed Private Security Agency only.

3. On 17.09.2019, Union Home Secretary wrote a letter to the Chief Secretary, Chhattisgarh for taking necessary measures for incident free elections in Dantewada.

4. On 04.09.2019, Maulana Masood Azhar, Hafiz Muhammad Saeed, Zakir-ur-Rehman Lakhvi and Dawood Ibrahim Kaskar were declared as individual terrorists and their names added to Schedule 4 of the Unlawful Activities (Prevention) Act, 1967.

5. During September 2019, sanction for prosecution for filing the charge sheet against 10 accused persons was accorded to NIA under section 45(1) of the Unlawful Activities (Prevention) Act, 1967 and section 196 of CrPC.

6. 5<sup>th</sup> Meeting of the Monitoring Committee on the Bru Repatriation was held on 06.09.2019 at New Delhi under the Chairmanship of Special Secretary (IS), MHA to discuss issues relating to repatriation of Brus from Tripura to Mizoram.

7. In the 24<sup>th</sup> Sectoral Level Meeting between India and Myanmar, held on 23 -24<sup>th</sup> September, 2019 at Myanmar, cooperation on internal security, management of international borders, cooperation in prevention of Drug Trafficking, Wildlife smuggling and issues of mutual concerns were discussed.

8. Cyber Crisis Management Plan (CCMP) of the Ministry of Home Affairs released on 10.09.2019.

9. On 20-09-2019, the Unlawful Activities (Prevention) Tribunal confirmed Government decision to declare the Jammu and Kashmir Liberation Front (Mohd. Yasin Malik Faction) (JKLF-Y) an unlawful association under the provisions of the Unlawful Activities (Prevention) Act, 1967.

10. During September 2019, 51 persons including 17 foreign nationals were arrested for their involvement in drug trafficking. More than 4698 kg of Narcotic substance was seized.

11. A meeting of the Project Clearance Committee (PCC) was held under the Chairmanship of Special Secretary (IS) on 16.09.2019 to approve the Proposal/ Action Plan of Governments of Andhra Pradesh, Chhattisgarh and Kerala under the Special Infrastructure Scheme, including construction of 250 fortified police stations.

12. An amount of Rs. 66.17 crore was released to LWE affected States as reimbursement under the Security Related Expenditure scheme. An amount of Rs 580 crore was released to LWE affected States under the Special Central Assistance (SCA) scheme for 30 most LWE affected districts.

13. 56 Coys of CAPFs were deployed in various States viz Telangana, Delhi, Bihar, Jharkhand, Uttar Pradesh, Gujarat, Madhya Pradesh, Maharastra, Karnataka, Punjab, Chandigarh for maintaining law and order duty during Friday Prayer, Ganesh Festival and Muharrum, DUSU Election, visit of VVIPs, law and order duties at Saharanpur and NTRO, Bhopal (MP).

14. On the recommendations of Election Commission of India, 144 Coys of CAPFs were deployed in connection with election duties in Uttar Pradesh, Kerala, Chhattisgarh, Tripura, Haryana and Maharashtra.

15. During the month, an amount of Rs.23.59 Crore for acquisition of land and Rs. 160.59 Crore for development of infrastructure were sanctioned to the CAPFs.

16. An amount of Rs.61.43 Crore was released under the Umbrella Scheme for Modernization of Police Forces during the month.

17. During the month, an amount of Rs.267.36 Crore was released under BADP to the State Governments of Arunachal Pradesh, Assam, Gujarat, Jammu and Kashmir, Rajasthan and Tripura.

18. During the month, three State Bills were assented by the Honble President of India. These are: 'The Bengaluru Dr. B.R. Ambedkar School of Economics University Bill, 2018', The Jharkhand University of Technology (Amendment) Bill, 2018' and The Tamil Nadu Agricultural Produce and Livestock Contract Farming 85 Services (Promotion & Facilitation) Bill, 2019'.
