Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of July, 2019.

On 15.07.2019 the High Level Committee (HLC) has been reconstituted under the Chairmanship of Former Judge, Gauhati High Court for implementation of Clause 6 of the Assam Accord. The first meeting of the HLC was held on 24.07.2019.

- 2. The Protection of Human Rights (Amendment) Bill, 2019 to amend the Protection of Human Right Act, 1993 was passed in the Lok Sabha and Rajya Sabha on 19th July, 2019 and 22nd July, 2019 respectively. The Protection of Human Right (Amendment) Act, 2019 was published in the Gazette of India on 27th July, 2019.
- 3. Union Home Secretary held a meeting on 02.07.2019 to discuss the issue of illegal immigrants in Nagaland. The meeting was attended by Dy. NSA, Director (IB), Special Secretary (Internal Security), Chief Secretary of Nagaland, RGI and other senior officers of MHA.
- 4. A Delegation, led by Ms. P. Michou, Director General for the Directorate General of Migrations, Home Affairs and Citizenship, European Union, met the Gol Delegation, led by Secretary (BM), on 10th July, 2019 in New Delhi, to discuss Strategic Cooperation on Cybercrime.
- 5. A Parliamentary Delegation of Commission-I (Law, Politics and Government) of the House of Representatives of Aceh, Indonesia, led by Mr. Azhari S.Ip, met Gol Delegation led by Special Secretary (CS) on 15th July, 2019 in New Delhi, to discuss issues concerning democratic system in India, Centre-State relations, good governance, public service and administrative reforms.
- 6. Civil List 2019 of the Indian Police Service was published during the month.
- 7. In the meeting of the Central Police Awards Committee (CPAC) on 26.07.2019, 188 recommendations for President's Police Medal (PPM) for Distinguished Service, 1141 recommendations for Police Medal (PM) for Meritorious Service, 77 Cases for President's Police Medal for Gallantry (PPMG)/ Police Medal for Gallantry (PMG) were considered.
- 8. Union Home Secretary chaired a meeting of the Sub-Committee of National Executive Committee (SC-NEC) on 22nd July, 2019 to consider the report of the Inter-Ministerial Central Team on damage caused by Cyclone "Fani" of 2019.

- 9. The NDRF personnel carried out rescue and relief in the area of deployment in co-ordination with State authority and rescued 33 personal and evacuated 16071 personnel during the month.
- 10. Sanction has been issued for creation of 106 posts in CISF for the purpose of induction in the Fire Wing.
- 11. 181 Coys and 2 bomb disposal dog squad of CAPFs were deployed in the States of Arunachal Pradesh, Odisha, Uttar Pradesh, Jharkhand, Telangana, Delhi, Uttarakhand, Jammu and Kashmir for maintaining law and order duties, Car festival of Lord Shree Jagannath at Puri, visit of VVIP at Varanasi district, Shrawan Mas Shivratri festival, Friday prayer at Hyderabad, Ghatam Procession, Sri Ujjaini Mahakali Jathara, Bonalu festival, Kanwaria Pilgrimage, Independence Day Celebration, Kanwar Mela at Haridwar. 47 additional Covs of CAPFs has also been deployed in the States of Tamil Nadu, Odisha and Tripura for election related duties.
- 12. During the month an amount of Rs. 131.71 crore has been sanctioned for acquisition of land and Rs 95.33 crore has been sanctioned for development of infrastructure to the CAPFs.
- 13. An amount of Rs. 12.40 crore has been sanctioned as Ex-gratia Compensation to the NOKs of CAPFs in 41 cases.
- 14. Sanction for prosecution for filling the charge sheet against 38 accused persons was accorded under the Unlawful Activities (Prevention) Act, 1967 for terrorist and antinational activities.
- 15 On 02.07.19, Union Home Secretary held a meeting with the Chief Secretaries and Director Generals of Police of LIVE affected States, Director Generals of CAPFs and IB to review the LWE scenario.
- 16. A meeting was held under the Chairmanship of Secretary (BM) on 18.07.19 with the Department of Telecommunications, and the Ministry of Information & Broadcasting to review the implementation of the various developmental schemes in the LWE affected areas.
- 17. A meeting of the Project Clearance Committee (PCC) was held under the Chairmanship of Special Secretary (IS) on 10.07.19 to discuss the Proposal/ Action Plan of the Government of Uttar Pradesh and Kerala under the 'Special Infrastructure Scheme, including construction of 250 Fortified Police Stations' in the LWE affected States.
- 18. An advisory was issued to the State Government / CAPFs to sensitize them on activities of Left Wing Extremists in the LWE affected areas.

- 19. During the month, an amount of Rs 14668.33 lakh has been released to the State Governments of Assam, Mizoram, Nagaland, Meghalaya and West Bengal under Border Area Development Programme (BADP). The total fund released under BADP during the Current financial year (2019-20) as on 31.07.2019 is Rs 17638.81 lakh.
- 20. During the month, an amount of Rs 32.48 crore in total has been released to the States of Mizoram, Kerala, Tripura, Nagaland, Chhattisgarh and Bihar under the relevant sub-schemes of the umbrella scheme of Modernization of Police Forces.

21. e-Visa facility has been extended to Benin and Belarus Nationals.
