

NOTIFICATION

In partial modification of this Ministry's Notification No.14016/01/2010-UTS.II dated 4th May, 2011, Under Clause (c) of sub-rule (2) of rule 7, read with sub-rule (1) of rule 10 of the NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli (Police Service) Rules, 2003, the Joint Secretary (Union Territories) in the Ministry of Home Affairs appoints Shri Sahab Ram (DOB: 15.08.1953) Inspector, (D-I/724) to the Entry Grade of NCT of Delhi, Andaman & Nicobar Islands, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli Police Service (DANIPS) in the scale of pay of Rs.9,300-34,800/- (Grade Pay Rs.4800/-) on probation for a period of two years with effect from 25th September, 2009 i.e. the date on which his immediate junior Shri Subhash Tandon, Inspector (D-I/887) was appointed to the Entry Grade of DANIPS. However, his appointment from 25th September, 2009 to 3rd May, 2011 would only be notional and the officer will not be eligible for back wages. He will be entitled to other consequential benefits, which may accrue to him under rules.

2. The appointment of Shri Sahab Ram (DOB: 15.08.1953) Inspector, Delhi Police to the Entry Grade of DANIPS would be subject to the outcome of CWP No.4210/2007- Jagdish Chand Versus Union of India and Another.
