No. HMA-19015/9/2019-POLITICAL(A) (eCF: 98854)/38:: Whereas the Government of Assam in exercise of powers conferred by Section 3 of the Armed Forces (Special Powers) Act, 1958 (28 of 1958) had declared the entire State of Assam as Disturbed Area vide notification No. HMA-19015/9/2019-POLITICAL(A) (eCF:98854)/24, Dated Dispur, the 27th February, 2019 beyond 28/02/2019 for a period of six months, and,

Whereas, a review of the law and order situation in Assam in the past six months indicates presence of extremist elements in certain parts of the State and besides the publication of NRC in the State being a sensitive matter that may lead to situations which may be exploited by extremist organizations to misguide the masses like the past attempts made by ULFA(I) during the agitations against CAB, 2016;

Now, therefore, as per powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958, the Governor of Assam is pleased to declare the entire State of Assam as "Disturbed Area" upto 6 (six) months w.e.f. 28/08/2019, unless withdrawn earlier.
