NOTIFICATION

G.S.R. No.251. LE. In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (LXI of 1951) read with sub-rules (1) and (2) of Rule 4 of the Indian Police Service (Cadre) Rules, 1954, the Central Government, in consultation with the Government of **Arunachal Pradesh**, **Goa and Mizoram** hereby makes the following regulations further to amend the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, namely: -

- (i) These regulations may be called the Indian Police Service (Fixation of Cadre Strength) Thirteenth Amendment Regulations, 2010
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Schedule to the Indian Police Service (Fixation of Cadre Strength) Regulation. 1955, under the heading "Arunachal Pradesh-Goa-Mizoram-Union Territories" for the entries occurring there under, the following shall be substituted namely:
