"It is certifying that the officers were neither convicted nor currently under investigation or being prosecuted for any criminal offence including violation of International Human Rights Law and International Humanitarian Law. It is also to certify that Government of India is aware that there is no allegation against

him/her as such and he/she has not committed or even involved, by act or omission, the commission of any act that may amount of violations of International Human Rights Law and International Humanitarian Law”

In view of the above, it is requested that the requisite certificate as per specimen mentioned in para-03, in respect of above officers, may please be submitted to this Ministry before **12th April, 2016** through e-mail at uspma@nic.in or through Fax at 011-23094009. It may be ensured that the certificate should be signed by a designated officer **not below the rank of Director/Deputy Inspector General** duly appointed by the concerned Government/Department/Organization for the purpose


