Reference MHA's E/Fax of even number dated 01 June and 27<sup>th</sup> June, 2016 on the aforementioned subject and to say that Shri Ajay Kumar Tripathi, Dy SP, UP Police, who has been nominated for Haiti mission (MINUSTAH) has intimated that due to posting/transfer, his phone number has been changed and thus he submitted fresh EASP with new contact details.

- 2. The fresh EASP submitted by the officer is enclosed with the request to forward the same to Police Division, UN HQ.
- 3. In this context, it is further submitted that there are 173 Police Officer in the UN SAAT panel of 2015-17. The validity of this panel will expire on **06**<sup>th</sup> **October**, **2017**. As per the selected panel, the deployment ratio is very meager.
- 4. The officers nominated for Haiti Mission fulfills the eligibility criteria required for MINUSTAH. Even though, India is having only English Armed Mission, yet, it is evident from the ToD extension request being received from Police Division, UN HQ that the officers having English Armed Mission are also indispensible to carry out mission mandate.

5. In view of the above, PMI to UN is requested to apprise Police Division, UN HQ about the contributions made by the Indian CIVPOL Officers (Armed English Mission) in the peacekeeping process of UN in Haiti and to issue the deployment orders in respect of following officers for their deployment to MINUSTAH at the earliest:-
