Submission of tender documents through any other mode except online will not be accepted by the Ministry. All the documents in support of eligibility criteria etc are also to be scanned and uploaded alongwith the Tender Documents. No tender documents will be accepted after the expiry of stipulated date and time for purpose under any circumstances whatsoever.

The earnest money deposit of Rs.50,00,000/-(Rupees Fifty lakhs only) in the form of Account Payee Demand Draft in favour of Pay & Accounts Officer, Ministry of Home Affairs, payable at New Delhi has to be submitted (Hard Copy to the Undersigned) in Room No. 94-C, Ground Floor, North Block, New Delhi-110001 latest by 04:00PM on 07-06-2017. Scanned copy of Demand draft must be attached online alongwith the technical bid documents failing which tender document would be rejected.

4. The Technical bids will be opened online on 09-06-2017 at 04.00 P.M. The technical bids will be evaluated by the Tender Evaluation Committee (TEC) constituted for the purpose by the Ministry. At the second stage, the Financial Bids of only those bidders who qualify in the technical bid will be opened later by the Committee members for which the notice will be issued separately.
