**Subject :- Nomination of Police Officers for deployment to UNFICYP, UNMIL and UNMISS.**

The UN SAAT test was held in India from 28<sup>th</sup> September, 2015 to 06<sup>th</sup> October, 2015. The validity of UN SAAT is 24 months i.e. from 06<sup>th</sup> October, 2015 to 06<sup>th</sup> October, 2017. Total 173 Police Officers are in the UN SAAT panel, 2015-17. After the UN SAAT, MHA had forwarded nomination of following police officers for deployment against the rotational vacancies, but no officer has been deployed with UN Mission so far:-


