Sir,

I am directed to refer to the subject and to say that PMI to UN vide their E/Fax No.197 dated 28th April, 2016 (copy enclosed) has intimated that Shri Swaraj Kumar Thapa, SI Meghalaya Police and Shri Devanabonia Pratap, DSP, Telangana Police will be considered for deployment to UN Mission in in next rotation as presently full authorized strength of UNPOL is deployed in UNFICYP. Ms Beena Thakur, Inspector, Uttar Pradesh was not recommended for the deployment. It is also intimated that the medical clearance of Shri Swaraj Kumar Thapa is still pending.

3. In view of the above, it is requested to furnish the following certificate in respect of Shri Swaraj Kumar Thapa, SI Meghalaya Police and Shri Devanabonia Pratap, DSP, Telangana Police to this Ministry by 10th May, 2016;

“that the officers were neither convicted nor currently under investigation or being prosecuted for any criminal offence including violation of International Human Rights Law and International Humanitarian Law. It is also to certify that Government of India is aware that there is no allegation against him/her as such and he/she has not committed or even involved, by act or omission, the commission of any act that may amount of violations of International Human Rights Law and International Humanitarian Law”

4. It may be ensured that the certificate should be signed by a designated officer not below the rank of Director/Deputy Inspector General duly appointed by the concerned Government/Department/Organization for the purpose
