- (a) Shri Vijaykumar V Pallewar, Assistant Commissioner, State Intelligence Deptt, MS, Mumbai vide his representation dated 05th April, 2016 (copy enclosed) has intimated that during his assessment by UN SAAT, in addition to the Technical Field, other fields of expertise like Crime Management and Protection and Training are also assessed through interview and endorsed by UN SAAT. UN SAAT matrix indicating his area(s) of expertise is enclosed. The copy of revised EASP duly certified by Shri Sukhwinder Singh, Joint Commissioner (Intelligence) State Intelligence Department, Maharashtra State, Mumbai and other supporting documents of State Govt showing his expertise in the field of Crime Management & Protection and Training received through the representation are enclosed.
- (b) Shri Mohammed Salim Shaikh, ASI, MHA was not considered for deployment to UNMISS saying that he has not filled out EASP properly and missing substantive information of his experience. The copy his representation dated 11<sup>th</sup> April, 2016 is enclosed.
- 2. In the case of Shri Mohammed Salim Shaikh, it is intimated that MHA received an e-mail from Mr Deepak Bhatt, Assistant to Military Adviser on 17.02.2016 regarding submission of fresh EASP after completing all observation as intimated by UNDPKO (copy enclosed). Shri Mohammed Salim Sheikh was requested on the same day to submit the EASP rectifying all observations of DFPKO. Accordingly, Shri Mohammed Salim Sheikh vide his e-mail dated 17<sup>th</sup> February, 2016 (copy enclosed) has submitted the rectified EASP and the same was sent to Mr. Deepak Bhatt, Assistant to Military Adviser, PMI to UN at <a href="militage-militage

UNMISS on the ground mentioned in para 02 of UNDPKO's reference: PD/817/16 dated 24<sup>th</sup> March, 2016 received through PMI to UN vide their E/Fax No. 199 dated 24<sup>th</sup> March, 2016 is not justified. The rectified EASP submitted by Shri Mohammed Salim Sheikh is again enclosed.

3. In view of the above PMI to UN is requested take-up the matter with UNDPKO to review the deployment cases of Shri Vijayakumar V. Pallevar, ACP, Maharashtra Police and Shri Mohammed Salim Sheikh, ASI, Ministry of Home Affairs for deployment to UNMISS.
