## Subject:- Amendment to Delegation of Financial Powers to Director Generals of CAPFs for procurement of stores etc.

In partial modification of this Ministry's Order No. 11012/2/2009-Fin-I dated 21.08.2009 and in supersession of this Ministry's Order No. 11012/2/2009-Fin-I/Prov.I dated 09.06.2014 on the above subject, it has been decided to enhance the financial powers delegated to DsG of CAPFs for procurement of stores etc as follows :

i.	Clothing & Tentage for Non-R/C items	Rs.6 crores	Rs.15.00 crore
ii.	Machinery & Equipment for both R/C and Non- R/C items	Rs.8 crores	Rs.20.00 crore
iii.	For Arms and Ammunitions from other than OFB	Rs.5.00 crore in each case	Rs.20.00 crore
iv.	For computer and peripherals both R/C and Non-R/C items	Rs.25.00 lakh in each case	Rs. 1.00 crore for IT equipment including software (except Note book/ Laptop computers*)
v.	For Trial evaluation of new items	Rs.50.00 lakh in each case	Rs. 1.00 crore for other CAPFs except NSG Rs.2.00 crore (for NSG only)

\* In terms of Order of Department of Expenditure, dated 19<sup>th</sup> September, 2014, powers of purchase of Notebook/Laptop computers shall continue to be exercised only by the Secretary of the Ministry/Department in consultation with Financial Adviser.

2. This would be applicable with immediate effect and for both provisioning and procurement.

3. Other conditions in MHA's Order No. 11012/2/2009-Fin-I dated 21.08.2009, authorization of weapon/equipment by the Government before procurement would continue.
