## ORDER


**Subject: Delegation of financial powers to DsG/Director, CAPFs/NIA/IB for procurement of Motor Vehicles for newly raised units/establishments of CAPFs/NIA/IB and against condemnation.**

Reference is invited to MHA's order No.IV-21012/01/2010/Prov.I/206 dated 02.02.2018 vide which DsG/Director of CAPFs/NIA/IB have been delegated financial powers for procurement of motor vehicles for their newly raised units/establishments up to Rs.20.00 crore in each case and to procure new vehicles against condemnation on "Category to Category basis (i.e. LUV to LUV)" instead to "Model to Model basis (i.e. Gypsy to Gypsy)".

2. Reference is also invited to MHA's UO No. 460 dated 26.06.2019 vide which it was conveyed that those units/establishments which have been raised after 01.02.2016 will be considered as "Newly Raised" only for the purpose of MHA's order dated 02.02.2018.

3. The MHA's Order dated 02.02.2018 and 26.06.2019 have been reviewed in this Ministry and **it has been decided to delete the term "Newly raised" from MHA's order dated 02.02.2018 with prospective effect.** Henceforth, the DGs/Director, CAPFs/NIA/IB may exercise their delegated financial powers up to Rs. 20.00 crore in each case for procurement of Motor Vehicles for their units/establishments against authorization irrespective of their date of raising. **Other conditions of MHA order dated 02.02.2018 would remain unchanged.**

4. This issues with the concurrence of IFD vide their diary No. 3603668/AS & FA (H)/Note # 26 dated 15.10.2022 and approval of Union Home Secretary on 26.10.2022.
