Subject:-Delegation of Financial Power to Officers of MHA In respect of various items-reg.


Sanction of the competent authority is hereby accorded for the delegation of financial powers to JS(PM) as follows:

SN	Items	Level to which power is delegated	Level of Delegation
1	Authorization sanction for various stores (other than operational vehicles) and Arms & Ammunition (A&A) for CAPFs/NIA/IB.	Joint Secretary(PM)	Full Power. (In consultation with IFD)
2	Provisioning/Expenditure sanction for various stores (other than operational vehicles) and Arms & Ammunition(A&A) for CAPFs/NIA/IB.	Joint Secretary(PM)	Rs.20 Crores (In consultation with IFD)
3	Mature Condemnation of vehicles	Full Powers delegated to Joint Secretary (PM) in consultation with IFD(H).	
4	Approval of Qualitative Requirement (QR) and Trial Directives(TDs)	Joint Secretary(PM)	

2. The above mentioned delegated financial powers shall be exercised by the respective officer subject to the following conditions:

- (i) The authorities to whom these powers are being delegated shall not further delegate these powers.
- (ii) All codal formalities should be followed as per the provisions laid down in GFR, DFPR, CPWD code/Works manual, Economy instructions and other instructions issued by the MoUD and MoF/MHA from time to time.
- (iii) Budgetary provision should exist in the financial year concerned.
- (iv) These powers would be exercised in consultation with the Integrated Finance Division (IFD), MHA.
- (v) Delegated powers will be exercised in terms of the general restrictions and conditions contained in the DFPR-1978, GFR-2005 and other general rules and orders issued by the Government from time to time.
