## OFFICE MEMORANDUM

Subject: Amendment of Recruitment Rules for the post of Proof Reader in Department of Official Language, Ministry of Home Affairs-reg.

The undersigned is directed to state that it is proposed to amend the Proof Reader, Department of Official Language, Ministry of Home Affairs, Recruitment (Amendment) Rules, 2016, as per the provisions given in para 3 hereunder.

**Essential:** A Degree with English and Hindi as subjects from a recognised University or equivalent & conversant with the art of Proof reading.

## Desirable:

- (i) Practical experience in the field;
- (ii) Knowledge of Sanskrit;
- (iii) Completed the 3 months training course in translation work conducted by the Central Translation Bureau.

**Note:1** Qualifications are relaxable at the discretion of the Staff Selection Commission/ Competent Authority in case of candidates otherwise well qualified.

Note:2 The Qualifications regarding experience is/are relaxable at the discretion of the Staff Selection Commission/ Competent Authority, for reasons to be recorded in writing in case of candidates belonging to the SCs or STs, if at any stage of selection the Staff Selection Commission/ Competent Authority is of the opinion that sufficient number of candidates from these communities possessing requisite experience are not likely to be available to fill up the vacancies reserved for them.

Age limit for direct recruits:-Between 18 and 27 years.

(Relaxable upto 35 years for Government servants accordance with the instructions or orders issued by the Central Government from time to time.) Note: The crucial date for determining the age-limit shall be the closing date for receipt of applications from candidates in India (other than those Andaman and Nicobar Islands or Lakshadweep). case In recruitment on direct recruitment basis through SSC. the crucial date for determining age-limit shall be advertised by SSC.
