

## **Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of June, 2022.**

Two meetings of the Parliamentary Consultative Committee for the Ministry of Home Affairs on the subject of "Disaster Management" and "Forensic Science Capacities: Strengthening for Timely and Scientific Investigation" were held under the chairmanship of Hon'ble Union Home Minister on 25.06.2022 & 26.06.2022 in Kevadia, Gujarat.

2. On 20.06.2022, a National Conference on "Cyber Apradh Se Azadi" was organized at Vigyan Bhawan. Hon'ble Union Home Minister inaugurated the Conference. It was attended by 1400 (approx.) persons from States/UTs Police, CAPFs, CPOs, judicial and students.
3. A meeting under the Chairmanship of Hon'ble Union Home Minister was held on 02.06.2022 to review the overall preparedness to deal with floods in the coming monsoon season.
4. High Level Committee (HLC) meeting was held under the Chairmanship of Hon'ble Union Home Minister on 15.06.2022 for Central Assistance to the States of Rajasthan and Nagaland respectively.
5. "38th National Police Training Symposium for Heads of Police Training Institutions" was organized by BPR&D at CDTI, Ghaziabad from 02.06.2022 to 03.06.2022 on the theme, "sharing of best practices in police training". Shri Nityanand Rai, Hon'ble MoS Home, inaugurated the training symposium and Shri Ajay Kumar Mishra, Hon'ble MoS Home, delivered the valedictory address.
6. On 02.06.2022, Union Home Secretary have taken a meeting with Mb o Rural Development, M/o Road, Transport & Highways, Government of Chhattisgarh and Government of Maharashtra to review the works under RRP-I and RCPLWEA Scheme in LWE affected districts of these States.
7. On 06.06.2022, Union Home Secretary have taken a meeting to review the certification of domestically manufactured equipment being used by NDRF for CBRN emergencies.
8. On 01.06.2022, Union Home Secretary met the Ambassador of Israel and discussed issues pertaining to mutual interest.
9. During the month, Rs. 47.15 crores have been released to Himachal Pradesh under BADP.
10. Sanction for prosecution for filing the charge-sheet against 13 accused person was accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967, during the month of June, 2022.

11. During the month, three Bills i.e. The Indian Partnership (Punjab Amendment) Bill 2021, The Criminal Law (Madhya Pradesh Amendment) Bill, 2019 and The Assam Agricultural Produce and Livestock Marketing (Promotion and Facilitation) Bill 2020 have been assented to by the Hon'ble President of India on 16.06.2022, 28.06.2022 and 29.06.2022 respectively.

12. A meeting under the chairpersonship of Additional Secretary (DM), MHA was held on 13.06.2022 to discuss the issue regarding indigenization of equipment used by NDRF for Disaster Management.

13. Sanction has been conveyed vide letter dated 23.06.2022 for transfer of 2663 sqm. land at 103 RAF Bn Wazirbad to NHAI for widening of NH-709B at a cost of Rs.3,73,725/-.

14. Total 84 Coys of CAPFs (RAF-37, CRPF-11, BSF-09, SSB-15, ITBP-04 & CISF-8) as direct induction have been ordered for deployment in various States/UTs of D&D and DNH, Chandigarh, Uttar Pradesh, Jharkhand, Telangana, Bihar, Andhra Pradesh, Karnataka, Punjab, Delhi, Gujarat & Odisha for law and order duties for a specific deployment period. Further, deployment period of 11 Coys of CAPFs has been extended during June, 2022 for the States of Delhi & Haryana for law and order duties.

15. Total 230 coys of CAPFs (CRPF-38, BSF-69, SSB-45, ITBP-21, CISF-12 & SAPs-45) as direct induction have been deployed in various States of Uttar Pradesh, NCT of Delhi, Tripura, Punjab, Andhra Pradesh & Jharkhand during Bye Election-2022.

16. During the month, the proposal of this Ministry for Cadre Review of Medical Cadre of CAPFs has been approved and the same communicated to all concerned vide this Ministry F.No. 45025/23./2018-Pers-1 dated 23.06.2022.

17. MoU between the NCB of the Republic of India and the NCB of the Republic of Indonesia has been signed on 17.06.2022 in New Delhi.
