Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of April, 2022.

Hon'ble Home Minister inaugurated the "48th All India Police Science Congress (AIPSC)" at CAPT, Bhopal, Madhya Pradesh on 22.04.2022. Chief Minister of MP, MoS (AM), Mos(NP) and the Home Minister of MP participated. The following publications viz. Police Vigyan and Data on Police Organization (DOPO) was released during this occasion.

- 2. A delegation led by H.E. Mr. Eammon Gilmore, Special Representative for Human Rights, European Union met with Union Home Secretary on 28.04.2022. The EU delegation raised some concerns on human rights. India's commitment to Human Rights and the extant mechanisms in our democratic set up to address the challenges related to HRs were reiterated.
- 3. On 20.04.2022, Union Home Secretary held a meeting with the Chief Secretaries of NE States to discuss various issues of Helicopter Services in NER.
- 4. MLAT in Criminal Matters has been signed with Poland on 25.04.2022 in New Delhi. SS(IS), MHA was the signatory from the Indian side.
- 5. A meeting between Additional Secretary (CIC), MHA and Mr Andrew Kefford, Australian Deputy Secretary, Department of Home Affairs was held on 05.04.2022. The meeting provided an opportunity to explore areas of potential bilateral security cooperation.
- 6. Ceasefire agreements with NSCN (NK) and NSCN (R) of Nagaland have been extended for a further period of one year till 27.04.2023. Ceasefire agreement with NSCN (K-Khango) of Nagaland has also been extended for one year upto 17.04.2023.
- 7. Meetings of the Joint Monitoring Committee (JMC) were held on 06.04.2022 under Additional Secretary (NE) with the Chief Secretaries of Tripura and Assam to review implementation of Bru Rehabilitation Scheme and Bodo & Karbi Agreement and with the Principal Secretary, Tripura to review implementation of Memorandum of Settlement(MoS) signed with NLFT(SD).
- 8. A review meeting was held on 19.04.2022 under Additional Secretary (LWE) for expediting installation of Mobile Towers under Phase II of the Mobile Connectivity Project in LWE affected areas.
- 9. Two Advisories were issued to State Governments/CAPFs to sensitize them to counter the LWE activities in the LWE affected areas.
- 10. The Indian Stamp (Telangana Amendment) Bill, 2020 has been assented to by the Hon'ble President of India on 31.03.2022.
- 11. During the month sanction for prosecution for filing charge sheets against 54 accused persons was accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967 in respect of cases relating to hatching of conspiracy & planning to undertake violent terrorist acts in Jammu & Kashmir and other anti-national activities.
- 12. Sanction was issued vide order dated 07.4.2022 for the visit of Director General Assam Rifles with delegation (03 staff officers) to Nepal, for Assam Rifles Ex-serviceman Rally during the year 2022.

- 13. During the month, a total 65 Coys of CAPFs (RAF-40, CRPF-08, BSF-02, SSB-06, ITBP-07 & CISF-02) as direct induction have been ordered for deployment in various States of Bihar, Jharkhand, Ladakh, Odisha, Madhya Pradesh, Gujarat, Telangana, Delhi and Uttar Pradesh for law and order duties for a specific deployment period. Further a total 02 Coys of BSF as direct induction have been ordered to deploy in West Bengal for Bye-Election related duties.
- 14. During the month of April, 2022, 15,031 kg of Narcotics substance, 53,675 tablets and 19,075 ampoules have been seized and total 54 persons were arrested for their involvement in drug trafficking.
- 15. All States/ UTs have launched their State Citizen Centric Portals for providing Citizen Centric Police Services connected to CCTNS. More than 9 crore citizen service requests have been handled.
