Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of July, 2022.

On 19.07.2022, Hon'ble Home Minister chaired a review meeting with the heads of Central Police Trainings Institutes in which DGs of CAPFs also participated.

- 2. On 30.07.2022, Hon'ble Union Home Minister also chaired a National Conference on "Drug Trafficking and National Security" at Raj Bhawan, Chandigarh with stakeholders from Central / State Government and Chief Ministers /Administrators / Lieutenant Governors of Punjab, Himachal Pradesh, Haryana, UTs of Chandigarh and J&K. In continuation of this, a Conference on "Thematic cum Technical Session" for discussion on drug related issues was also held on 31.07.2022 with Chief Secretaries of concerned States and representatives from Central/ State Governments.
- 3. On 01.07.2022, Union Home Secretary held a meeting with the High Commissioner, Sri Lanka.
- 4. Union Home Secretary also chaired a meeting on 14.07.2022 to discuss the feedback report on MMPDS (Multi Mode Passive Detection System).
- 5. A Meeting was held on 05.07.2022 under the Chairmanship of AS(LWE) with the representatives of CAPFs and NYKS to review the implementation of MHA schemes i.e. ACALWEMS, Media Plan and CAP.
- 6. Three Central Level Committee (CLC) meetings were held on 06.07.2022, 07.07.2022 & 11.07.2022 under the Chairmanship of AS (LWE) with the Nodal Officers /DCs/DMs/SPs/DFOs of Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Kerala, Maharashtra and Odisha to review the progress of Special Central Assistance (SCA) Scheme in LWE affected districts and districts of concern.
- 7. A Meeting (through VC) was held on 08.07.2022 under the Chairmanship of AS(LWE) with the Nodal Officers of 09 LWE affected States to review the progress of works under Special Infrastructure Scheme (SIS) in LWE affected areas.
- 8. On 22.07.2022, sanction for prosecution was accorded against 07 accused persons in accordance with section 188 of CrPC in respect of NIA Case relating to seizure of Counterfeit/ Fake Indian Currency Notes (FICN) worth Rupees 72.50 Lakh of 1000 and 500 rupee denomination.
- 9. On 28.07.2022, sanction for prosecution for filing the charge sheet against 5 accused persons was accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967.
- 10. On 29.06.2022, approval has been granted for Categorization of the Coalition for Disaster Resilient Infrastructure (CDRI) as an "International Organization" and signing of Headquarters Agreement with CDRI for granting exemptions, immunities and privileges as contemplated under the United Nations (Privileges and Immunities) Act, 1947 to CDRI.

- 11. BPR&D organized a national symposium on "Trends in Dark net Crimes and Monitoring Techniques (Special focus on Crypto currency driven crimes)" on 30. 06.2022, in which 512 personnel participated.
- 12. On 15.07.2022, a meeting of the members of "Micro Mission:03 (Communication & Technology)" was held under the Chairmanship of the DG, BPR&D.
- 13. An advisory was issued to all Registrar of High Courts to hold Judicial Colloquium on Human Trafficking to sensitize the Judicial officers of all State /UTs.
