
QR FOR CDO DAGGER FOLDING


1. Folding Commando Dagger is required for use by Special Forces. It will be carried covertly in plain clothes. It will be employed to launch surprise attack on terrorists for hostage rescue most likely in enclosed places.
2. QR for Cdo Dagger Folding are as under:-
Stainless
 - (a) Made of ~~non-rustable metal~~ preferably steel.
 - (b) Length of Blade must be adequate to neutralize the opponent i.e. Blade should not be either too long or too short. (4 inches \pm 1/2 inch).
 - (c) Weight of dagger should not be more than 250 gms.
 - (d) Handle of Blade must have good hand grip.
 - (e) It should be folding pattern.
 - (f) Blade should have jagged edge to increase lethality.
 - (g) Must be easy to conceal.
3. Minimum two sample pieces are required for trial evaluation.






