
The undersigned is directed to refer to this Ministry's notification dated 23.07.2018 regarding statutes, rules and SOP for the award of **“Utkrisht Seva Padak”** and **“Ati Utkrisht Seva Padak”** and to say that this Ministry vide Notification No 11024/60/2022-PMA(2) dated 21.09.2022 had discontinued the aforementioned medals with immediate effect for the members of Central Armed Police Forces, Central Police Organizations, Assam Rifles, National Security Guard, Intelligence Organizations of the Central Government/CAPF. A copy of MHA's Notification No 11024/60/2022-PMA(2) dated 21.09.2022 is enclosed herewith.

2 However, the **“Utkrisht Seva Padak”** and **“Ati Utkrisht Seva Padak”** will remain available for permanent police personnel, other permanent support staff, Home Guards working in State/UT Police forces. The power for award/approval of these medals is delegated to the Competent Authority in States/UTs. The overall work for these medals like fabrication of medal and cost incurred thereon is transferred to States/UTs concerned. Ministry of Home Affairs, Government of India will now have no role for award/fabrication/distribution of these medals.
