Sub: Implementation of recommendations of the Seventh Central Pay Commission relating to grant of Detachment Allowances to Central Armed Police Forces (CAPFs), Assam Rifles and NSG – regarding.

Consequent upon the decision taken by the Government on the recommendations of the Seventh Central Pay Commission, as per Resolution No.11-1/2016-IC dated 6th July, 2017 issued by MoF, the President is pleased to decide that, in modification of this Ministry's OM No.II-27012/67/2008-PF.I dated 18.02.2009, and OM No.II-27012/67/CF-40400/2008-PF-I dated 07.02.2014, the admissibility of Detachment Allowance to CAPFs, AR and NSG shall be as under:-

- 2. The rate of this allowance will increase by 25 percent each time the DA increases by 50 percent. The CAPF personnel will now have the following options to choose from:
 - a. Detachment Allowance + [Special Duty Allowance (as and where applicable) OR Tough Location Allowance (as and where applicable)]

OR

- b. Risk and Hardship Allowance (as and where applicable) + Ration Money Allowance.
- 3. No Ration Money Allowance will be granted with Detachment Allowance. Where free rations are provided, only 50 percent of the Detachment Allowance will be granted.
- 4. The Detachment Allowance will be enhanced by 50 percent in both J&K as well as LWE theatres.
- 5. Detachment Allowance will be granted at full rate for first 10 days, at 75 percent of the full rate for next 10 days and at 50 percent of the full rate for the remaining period. The existing conditionality of return to HQ for continuation of the allowance beyond 180 days is hereby removed. Remaining conditions governing payment of Detachment Allowance shall remain unchanged.
- These orders shall be effective from 1st July, 2017.
