**OFFICE MEMORANDUM**

**Sub: Implementation of recommendations of the Seventh Central Pay Commission Regarding Grant of Education Concession to children of CAPFs, AR & NSG personnel who are missing/disabled/killed in action.**

Consequent upon the decision taken by the Government on the recommendations of the Seventh Central Pay Commission, vide Ministry of Finance's Resolution No.11-1/2016-IC dated 6<sup>th</sup> July, 2017, the President is pleased to sanction Education Concession to children of CAPFs, AR & NSG personnel who are missing/disabled/killed in action, as under:-

Tuition Fees	Full Reimbursement
Hostel Charges	Full Reimbursement
Cost of books/stationery	Rs.2000 per annum
Cost of Uniform	Rs.2000 per annum
Clothing	Rs.700 per annum

2. The combined amount of Tuition Fees and Hostel Charges shall not exceed Rs.10,000 pm. The allowance shall go up by 25 percent each time DA rises by 50 percent.
3. These orders shall be effective from 1<sup>st</sup> July, 2017.
4. This issues as per 7<sup>th</sup> CPC recommendations in para 8.17.44-45 read with MoF's Resolution dated 6.7.2017, as vetted by Integrated Finance Division of this Ministry vide their Dy. No. CF-3396699/Fin.II/17 dated 2.8.2017.


