PMI to UN has forwarded Police UNDPKO's request for nomination upto 02 Training Police Officers to participate in United Nations Training of Trainers Course on Child Protection for UN Police, from 01 to 05 October, 2018 at the Peace Support Training Centre (PSTC), in Kingston, Ontario, Canada that is conducted by the Integrated Training Service of the Division of Policy, Evaluation and Training (DPET), Department of Peacekeeping Operations (DPKO) and Department of Field Support (DFS), in cooperation with the Government of Canada.

- 2. The invitation, Objective along with the requisite eligibility criteria, instructions and Financial conditions for mentioned course are enclosed/attached with this letter for needful reference. It is strongly recommended to nominate only those Police Training Officers who are engaged in delivering UN pre-deployment training for Police personnel. The Nominations of the female candidates are highly encouraged.
- In view of above, It is requested that nomination of eligible and willing officers of rank of Inspector or above may be submitted through proper channel to this Ministry by 10<sup>th</sup> August, 2018 alongwith the following documents duly completed in all respect:

- ii. Registration form (proforma attached) along with Passport Photo and copy of official passport

- The nominated officers may be advised to send the above **document** as per the format enclosed **through electronic mail at e-mail address** at <u>uspma@nic.in</u>. (Mandatory) in pdf format only before the deadline
- 5. No modified format other than the specimen enclosed duly typed will be entertained/accepted as it invites lot of observations from UN HQ (UNDPKO) while finalizing the nominations. Hand written registration form will not be entertained/accepted. It may be ensured that the photograph of the officers applying should be placed
- 6. It may please be ensured that the nominees are clear from Vigilance angle and Necessary Cadre Clearance (for all Officers) from MHA/State Government/CAPFs/any other lending organization must be forwarded with nomination. (without cadre clearance and NOC from parent cadre, nominations will not be entertained).
- 7. **No direct application will be entertained**. Applications through proper channel only i.e. through Home Department(State)/approval of Head of Organization will be entertained. Applications received after the deadline specified will not be accepted. All Costs associated with participating in the Course (airfare, meals and accommodation) will be borne by United Nations and the Government of Canada. All required transit and entry visas must be the responsibility (monetary & administrative) of the participants.
- 8. All the officers may be advised not to make any direct contact with UNHQ authority. Nomination through MHA only will be considered.

- 1. The Integrated Training Service (ITS) of the Division of Policy, Evaluation and Training (DPET), Department of Peacekeeping Operations (DPKO) and Department of Field Support (DFS), in cooperation with the Government of Canada, will conduct a United Nations Training of Trainers Course on Child Protection for UN Police, from 01 to 05 October 2018 at the Peace Support Training Centre (PSTC), in Kingston, Ontario, Canada.
- 2. The aim of the course is to strengthen the capacity of Member States to deliver UN-required Child Protection training for police personnel deploying to Peacekeeping Operations, especially in challenging environments where Child Protection is mandated by the Security Council. The programme will introduce the new training package of specialized training materials and enable participants to practice delivery of the training materials.
- 3. In view of the above, ITS would like to extend an invitation to nominate up to two police training officers to attend this course. Candidates must be either engaged in delivering UN predeployment training for national police personnel, about to be allocated this responsibility or be responsible for overseeing the delivery of such training. Candidates must be fully fluent in English. Nominations of female candidates are highly encouraged. ITS will conduct a selection process once the nominations are received and will decide on the participants of the course accordingly. All the candidates are requested to submit their CV.
- 4. Participants will be assessed and those who pass will be awarded a certificate of proficiency. A number of participants will be also identified as potential members of future ITS-led Mobile Training Teams (MTT). Those who are identified for the roster may be requested, upon approval from their governments, to conduct other TOT courses in conjunction with our staff.

- 5. All costs for travel, accommodation and meals will be borne by ITS and the Government of Canada. The nominees must have a valid medical insurance while attending the course in Canada. First aid will be provided by the host country.
- 6. All required transit and entry visas must be obtained by the participants. Please ensure your participants receive the visa prior to travel. Please also note that obtaining visas is a bilateral agreement between the traveller and the entry or transit country; therefore, it is the sole responsibility (monetary and administrative) of the participating Member State.
- 7. Nominations should be submitted **through the Permanent Mission to the UN** by email no later than **20 August 2018**, using the attached registration form, along with a scanned copy of the candidate's passport bio page, to Ms. Oyuna Tsogt at <a href="mailto:tsogt@un.org">tsogt@un.org</a> and Mr. Jan Koller at <a href="mailto:koller@un.org">koller@un.org</a>, with a copy to the Course Director Mr. Esteban Sanchez-Reyes at <a href="mailto:esteban.sanchez-reyes@un.org">esteban.sanchez-reyes@un.org</a> and the Course Manager Ms. Katharina Waczek at <a href="mailto:katharina.waczek@un.org">katharina.waczek@un.org</a>.
