Allocation of MBBS/BDS seats to the wards of CAPFs

During the Academic year 2018-19, 15 MBBS and 3 BDS seats were allocated from Central Pool quota for the wards of Central Armed Police Forces (CAPFs) personnel by Ministry of Health & Family Welfare vide their O.M. No. U.14014/4/2018-ME-II dated 13.08.2018. As per instructions issued by MoHF&W, 22½% of the above seats have been allocated to the candidates belonging to Scheduled Castes/Scheduled Tribes. Further, as per this Ministry's O.M.No. 27011/109/97-PF-I dated 24.03.1998, the procedure for allotment of seats to wards of CAPFs & AR personnel was allocated is as under:-

a) Priority-I: Those killed in action.

b) Priority-II : Permanently disabled in action and boarded out

from service.

c) Priority-III: All serving and retired personnel.

3. The counseling on the subject matter was held on 28.08.2018 under the Chairmanship of IG(Pers) BSF at CGO Complex, Lodhi Road, New Delhi and all MBBS/BDS seats were allocated to the eligible candidates in order of their marks/merit in NEET and preferences of colleges opted by them as per details given below:-
