The Secretariat of the United Nations presents its compliments to the Permanent Mission of India to the United Nations and has the honour to inform that Mr. Ravi Gandhi has been found the most suitable candidate for appointment on secondment for the post of Senior Police Adviser (P-5) in the United Nations Peacekeeping Force in Cyprus (UNFICYP), as advertised through Job Opening DPKO-UNFICYP-0194-2018.

The Secretariat also wishes to inform the Permanent Mission that it will contact the candidate directly to formalize the offer of appointment. The finalization of Mr. Gandhi appointment will be subject to human rights clearance, administrative and medical clearance by the UNFICYP's relevant administrative units as well as other United Nations staff rules and procedures.

The Permanent Mission shall confirm the concurrence of the authorities of Permanent Mission of India for the secondment of Mr. Gandhi to the United Nations. In accordance with General Assembly resolution 45/239 II.4 (1990), the current procedures for secondment from government service require that the conditions of service affecting the individual, who is to serve on secondment, and his agreement to the tripartite secondment agreement be properly recorded. To facilitate this, the Permanent Mission may wish to avail itself of the standard form (copy attached) for its reply. This form will be attached to the United Nations Letter of Appointment given to the staff member, which will include a special condition that the staff member is serving on secondment from his Government and that the conditions governing his right to return to government service are specified in the above-mentioned attachment.

The Secretariat wishes to emphasize that it is the responsibility of the Government to ensure that the selected candidate has not been convicted of or is not currently under investigation or being prosecuted for, any criminal or disciplinary offence, or any violations of international human rights law or international humanitarian law. In the case of the nominee who has been investigated for, charged with or prosecuted for any criminal offence, with the exception of minor traffic violations (driving while intoxicated or dangerous or careless driving are not considered minor traffic violations for this purpose), but was not convicted, the Government is requested to provide information regarding the investigation(s) or prosecutions concerned. The Government is also requested to certify that it is not aware of any allegations against the above candidate that they have committed or been involved, by act or omission, in the commission of

any acts that may amount to violations of international human rights law or international humanitarian law.

The Secretariat recalls that it has a zero-tolerance approach to fraud and corruption. The Government is therefore requested to certify that there was no corruption or fraud in the nomination and extension procedures of police officers on secondment to the United Nations. Should the Secretariat become aware of allegations of corruption or fraud in the nomination or extension procedures of police officers on secondment, this may constitute grounds to revoke its acceptance of such personnel to serve in the United Nations as well as suspension of any future police deployments from the contributing country concerned.

The Secretariat of the United Nations avails itself of this opportunity to renew to the Permanent Mission of India to the United Nations the assurances of its highest consideration.
