Principles to be followed while determining the IAS, IPS & IFS cadre strength of the States of residual Andhra Pradesh and Telangana.

- 1. Existing IAS, IPS & IFS cadre strength of Andhra Pradesh to be bifurcated without any change in the overall cadre strength.
- Bifurcation of cadre strength will be in the ratio of 13:10 for residual Andhra Pradesh and Telangana which is the ratio of number of districts in the newly formed States.
- 25% of the Senior Duty Posts (SDP) constitute State Deputation Reserve (SDR) and utilized as ex-cadre posts. The State Governments may have the flexibility to create ex-cadre posts subject to the following:
 - The number of ex-cadre posts at the Apex level shall not exceed the number of cadre posts.
 - ii) Overall State Deputation Reserve (ex-cadre posts) shall not exceed 25% of the senior duty posts in a cadre.
- 4. No upgradation or downgradation of cadre posts shall be allowed.
- 5. The Central Deputation Reserve (CDR) should not exceed 40% of Senior Duty Posts in a cadre. The Training Reserve and Leave Reserve & Junior posts Reserve should not exceed 3.5% and 16.5% of the Senior Duty Posts respectively.
- Generic nomenclature may be used to define the posts at various levels so that the State Governments shall have the flexibility to use in order to meet their requirement.
